(2) The Assembly shall fix the dates from which, subject to the provision of paragraph (1), international applications may be filed and demands for international preliminary examination may be submitted. Such dates shall not be later than six months after this Treaty has entered into force according to the provisions of Article 63(1), or after Chapter II has become applicable under Article 63(3), respectively.

Article 66 Denunciation

- (1) Any Contracting State may denounce this Treaty by notification addressed to the Director General.
- (2) Denunciation shall take effect six months after receipt of the said notification by the Director General. It shall not affect the effects of the international application in the denouncing State if the international application was filed, and, where the denouncing State has been elected, the election was made, prior to the expiration of the said six-month period.

Article 67 Signature and Languages

- (1)(a) This Treaty shall be signed in a single original in the English and French languages, both texts being equally authentic.
- (b) Official texts shall be established by the Director General, after consultation with the interested Governments, in the German, Japanese, Portuguese, Russian and Spanish languages, and such other languages as the Assembly may designate.
- (2) This Treaty shall remain open for signature at Washington until December 31, 1970.

Article 68 Depositary Functions

- (1) The original of this Treaty, when no longer open for signature, shall be deposited with the Director General.
- (2) The Director General shall transmit two copies, certified by him, of this Treaty and the Regulations annexed hereto to the Governments of all States party to the Paris Convention for the Protection of Industrial Property and, on request, to the Government of any other State.

This is a document which is intended to detail all the 36 sale agreements / 36 deals for a full value of 93 Trillion Earthlings / \$ that have been listed as part of document 28 attached with plaint. How the patent for USA territory US 8,910,998 and 17 national stage patent applications have been converted to 36 deals is explained at a high level in the plaint paragraphs 61 and 62. The full analysis of the Automotive industry and the arrival of sale price of 18 patents / applications is given towards the end of this document. In summary, while 16 individual country patents / applications translate to 16 deals, 38 countries covered by EPO patent application translate to 12 deals, and 8 countries covered by EAPO patent application translate to 8 deals, totaling to 36 deals / 36 separate 'IP RIGHTS SALE AGREEMENTS' covering all my chosen 62 countries for patent protection.

- 1. European commission (European Union) is expected to execute one agreement on behalf of all 27 EC member countries. These 36 deals listed above total to the full value of global IP rights sale price of 93 Trillion Earthlings. The completion of these deals will ensure systematic distribution of the IP rights to my invention of US 8,910,998 (and PCT international application PCT/US2014/046619) to all 62 countries where I have applied for IP rights protection via 17 national stage patent applications.

Automotive Industry analysis and data

3. The valuation of my invention has been done based on detailed study of all the automotive manufacturing plants across the world, segregated by individual countries, their manufacturing through-put, the market size projection for the 100-year period; and all the related business opportunities such as plastic – polymers industry, paints industry, chemicals – additives industry, robotics industry, and all these sectors respective market sizes.

- 4. I spent several months (nearly 2 years) by having analysts gather all vehicle manufacturing data from across the world, by countries and by each manufacturing plant. This allowed me to identify the Automotive manufacturing countries (which are the points of infringement of the invention and technology), 62 in all from the PCT contracting states. These 62 countries would cover over 99% of automobile production in the World.
- 5. I would like to point to the Hon'ble court that I have captured car manufacturing data and motorcycle (two-wheeler) manufacturing data separately. I have detailed automotive industry analysis and have data captured at the level of each automobile manufacturing plant and rolled up to the manufacturing data by each OEM (Original equipment manufacturer) brand. Then the data was segregated by each country. This was done to identify in which countries I must enter national stage using my PCT international application. After thorough analysis of the industry data by countries, I identified the main automotive manufacturing countries which were 61 non-USA countries which could be covered by 17 national stage applications. These are the PTO jurisdictions or territories where I filed for national stage applications. I invested the money I had wisely after doing thorough market study. I state that I will provide any insight, data, information pertaining to the automotive industry and the data I have captured up on the request of the Hon'ble court. Because I entered 'National stage' (given the PCT procedural deadlines), between 23-9-2016 to 18-11-2016, all the data crunching of automotive industry was done in years 2015 and 2016, which was based on 2013 automotive industry data. The annual reports, manufacturing, and sales data of OEM'S that was fully available was of that of year 2013. 2014 data had only partially appeared and put out by OEM'S. I also mention that automotive OEM'S information is fully in public domain, as all the automotive OEM'S in the world are publicly listed companies which publish annual reports for the benefit of shareholders and citizens. I would like to present the following summary view (in next page) of automotive industry 2013 data of cars production, to the Hon'ble court. The numbers in the table must be read as approximated numbers for that year, as the data from multiple sources, different methods of calculations were adopted by me. The Hon'ble court must consider the numbers in the range or as ball-park industry numbers for the benefit and evaluation of this lawsuit. Up on request, I would provide more data / information to the Hon'ble court. The numbers in year 2019 were better and higher, as per industry sources. However, this year, all businesses and sectors have been negatively affected given the Covid situation. Similarly, the automotive industry has been negatively affected. To project the next 100-year car manufacturing activity, I have taken these numbers and applied a CAGR of 2% and extrapolated the numbers. The resulting number will be the 100-year economic activity due to cars manufacturing in 2013 \$. This number does not include the economic growth rates of countries across the World and thus the resulting inflation causing the currency to depreciate and increase in purchasing power. When these factors are taken in, one can say the sale price of a car in India, China, Russia, Brazil, or South Africa will increase by 5 times in 100-years. This is pegged at car sale price increasing by around 40% in every 20 years. Based on past data this will easily be achieved or beaten. Maybe in some territories (including BRICS), the car price may double in 25 years or 33

years. After factoring in these economic growth rates and inflation numbers, the 100-year economic activity could realistically be around 1500 Trillion or aggressively at 2500 Trillion. I have chosen a conservative 930 Trillion and claimed 10% of it, as it would be an undisputed claim. I could easily claim a realistic 125 Trillion as my global IP rights sale price.

In the table above, production value computation used 2015-year local currency to \$ conversion rates. These numbers would be different today. It must be observed that while China manufactures the most units per year, its production value is lower than that of Europe.

My Invention, its global IP rights sale price valuation of 93 Trillion Earthlings / \$ and its breakdown across 18 applications resulting in 36 deals, covering 62 countries.

- 6. I would like to state that 'Intellectual Property enforcement rigor' is a key factor used to arrive at the final sale price of the IP rights by the territories. Countries like Europe, Japan, Korea, Canada, Australia, New Zealand have higher levels of IP law practice, enforcement, and rigor. USA is supposed to have strong enforcement of IP law, except that they commit fraud as explained in this lawsuit, to block Indian nationals by deliberately blocking their inventions. Mexico and Brazil are also supposed to have good IP law enforcement rigor. China is the largest automobile manufacturer in the World however is supposed to have relatively weak IP law enforcement in their country. Many other countries listed in the table above have moderate to weak IP law enforcement in their territory.
- 7. The automotive industry market size from year 2013 was taken and extrapolated to identify the next 100 years-worth economic activity. An observed growth trend over the last 30 years was taken as CAGR and applied for the extrapolation. The Automotive Industry alone contributes to over 500 Trillion USD of economic activity, in 2013 \$. When inflation numbers and economic growth rates are taken and applied over the 100-years, and further all the other downstream businesses and their market sizes are added, the economic activity over the next 100 years would easily cross 2000 Trillion. An aggressive estimate places the economic activity related to the invention between 2000 and 2500 Trillion. A realistic estimate is in the range of 1250 to 1500 Trillion. I could claim a 10% of the realistic projection at 125 Trillion or 150 Trillion as the sale price to global IP rights in the current year. However, I have chosen a conservative estimate of 930 Trillion as a confirmed (globally accepted) projected economic activity. And I am claiming only a 10% at 93 Trillion as the global IP rights sale price. There has been a detailed statistical analysis that has been done before this global IP rights sale price has been set and it is further set at a value which would be unanimously agreed to and approved - voted by all 193 countries, if their opinion were to be considered at United Nations. I am claiming a conservative 10% of this 100-year economic activity, at 93 Trillion \$ / Earthlings, as a single buy-out / sale price of the invention across all 62 countries where I have sought protection including USA. At 12%, the global valuation (buy-out / sale price) will be at 111.6 Trillion \$; and at 15%, the global valuation (buy-out / sale price) will be at 139.5 Trillion \$. In many prior inventions, Inventors have sought 12% or even 15% as their earnings off the invention. hence those numbers are also listed. However, finally I have chosen to claim 93 Trillion as final sale price of my global IP rights and have further broken it down to 36 largest deals listed as part of document 28.

8. Based on the factors mentioned in above paragraph, the final sale price of the IP rights for each territory where I have applied for IP rights protection is given in the table here. I have applied for a total of 18 patent applications covering 62 countries. The IP rights sale price or the sale price of these 18 applications is given in the table here:

- 9. If the above list of 18 PTO jurisdictions is observed, a single IP rights sale agreement would cover each of the following 16 PTO jurisdictions which are individual countries, USA, New Zealand, Korea, Japan, Australia, Brazil, Canada, China, India, Mexico, Thailand, Philippines, Malaysia, Indonesia, Nigeria, and South Africa. The IP rights for India could be assigned to Indian government or will be directly assigned by me to private companies in India. This subject is linked to the Living Will as executed by me and attached to this plaint as document 21.
- 10. The other two PTO jurisdictions Europe and Eurasia cover 38 countries and 8 countries, IP rights, respectively. I would like to discuss Eurasian application first. It covers the eight countries Russian Federation, Kazakhstan, Belarus, Azerbaijan, Turkmenistan, Armenia, Kyrgyzstan, and Tajikistan. Due to a variety of factors, though these eight countries function and operate under a single PTO jurisdiction, they may not choose to function as a single trade union to receive the IP rights of all 8 countries to a single organization or entity. So, I have broken down the sale price of Eurasian patent application 0.45 Trillion across the 8 countries in proportion to the GDP of these 8 countries based on 2018 actual nominal GDP numbers as published by United Nations and accessible via Wikipedia.
