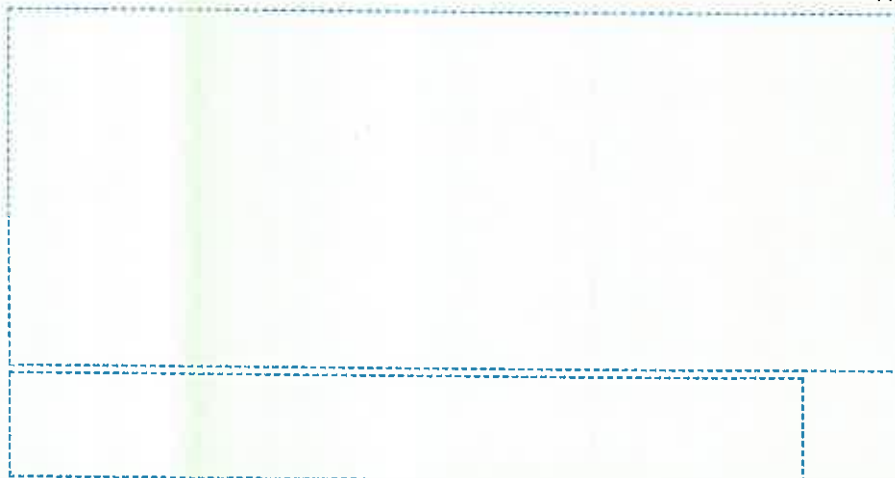

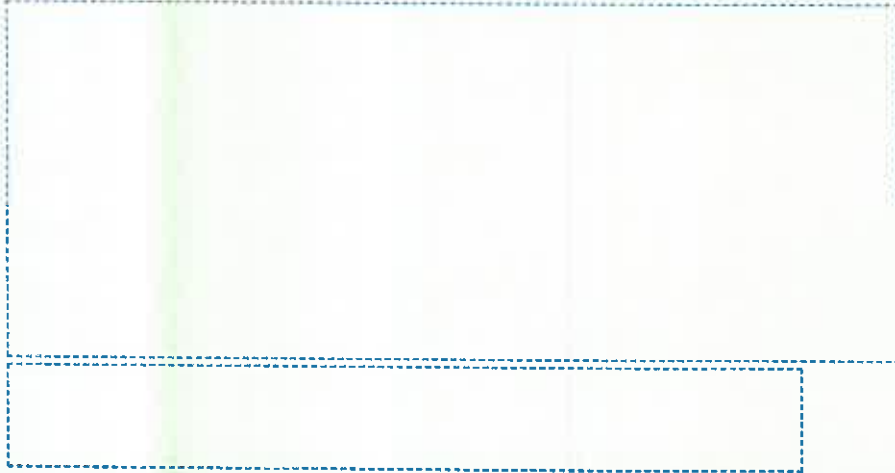

We attach a copy of an examination report which has issued from the Intellectual Property Office of New Zealand (IPONZ), along with a copy of the claims considered by the Examiner and our debit note.

Deadline for response

The deadline for filing a substantive response to this report is **24 April 2018**. This deadline is extendable by one month to **24 May 2018** if requested within the extended period.

Deadline for acceptance

The final deadline for overcoming all report objections and obtaining acceptance of this application is **24 October 2018**.

We emphasise that no extension of the acceptance deadline is available, and that it is necessary for the application to be placed in order for acceptance and actually accepted by that date.

The application will irrevocably lapse if not accepted by the final deadline.

Objections raised

Item 3: Consideration of Chapter II (Article 34) amendments

The Examiner has not considered the Chapter II amendments filed at WIPO. In New Zealand, for Chapter II amendments to be considered a complete specification along with a marked up specification needs to be filed, along with a statement of support advising that the amendments correspond to those filed at WIPO. We will proceed to file the amended claims when responding to the examination report, however before we do you may consider making further amendments in light of the objections outlined in items 5 to 12 (below).

Item 4: We note that item 4 is not an objection, and that it can be disregarded.

Item 5: Formality Objection (units)

In item 5 the Examiner has raised a formality objection with respect to the use of 'Fahrenheit' in paragraphs [0004], [0010], [0054], and claim 4. The Examiner has requested that the units be changed to Celsius. We will attend to this when responding to the examination report.

Item 6: Abstract not Suitable

In item 6, the Examiner has raised an objection in relation to the abstract. In New Zealand the abstract is required to describe the problem(s) in the existing art which the invention seeks to address, what the invention is, and how it addresses the problem(s). Upon briefly reviewing the specification we have compiled a revised abstract based on the problems outlined in paragraph [0007], and claim 1:

"A need exists for an efficient and cost-effective system and method for altering the color and/or visual appearance, and/or the tactile/texture/feel of a vehicle, or any other object or surface thereby reducing lost time, reducing expense, increasing manufacturing productivity, and reducing or eliminating many of the difficulties inherent in maintaining and transporting inventories, while providing consumers with the ability to flexibly alter characteristics of their vehicle or any other surface, repeatedly. The present invention addresses this need by providing a system for altering the appearance of a vehicle surface, the system comprising: a vest comprising an edge wherein at least a portion of the vest is at least partially foldable or at least partially stretchable, wherein the vest is secured to the vehicle surface and an exterior side spaced from the vehicle surface to define a fluid-tight space between the exterior side of the vest and the vehicle surface, wherein the exterior side is at least partially transparent, at least partially

translucent, or combinations thereof for enabling visualization of visible media in the fluid-tight space through the exterior side; and at least one port communicating between the fluid-tight space and a region exterior to the fluid-tight space for receiving visible media into the fluid-tight space, removing visible media from the fluid-tight space, or combinations thereof."

We note that if claim 1 is further amended, then the abstract will need to be amended to reflect the changes. We ask that you please review the revised abstract, and that you provide us with your approval to file the amended abstract. Otherwise we look forward to receiving your comments and/or amendments regarding this objection.

Item 7: Formality Objection to Figure Numbering

Due to recent legislative changes, IPONZ now requires that all Figures be number sequentially with the use of roman arabic numerals. This means that any figure numbers containing letters or roman numerals will give rise to an objection. We will proceed to address this objection when responding to the examination report by renumbering Figures 8A and 8B as Figures 8 and 9, and updating the description of the specification to reflect this change.

Item 8: Support Objection to Claim 12

In item 8 the Examiner submits that claim 12 lacks support as there is no explicit mention of "barrier, protrusion or recess" (or plural thereof) in the description. New Zealand law requires the full breadth of a claim to be supported by the disclosure of the originally filed specification and to provide sufficient information to enable the skilled addressee to perform the invention over the full scope of the claims.

In order to overcome this objection, we must either:

- advise the Examiner of the location of the passages in the specification that support the full breadth of claim 12,
- demonstrate with reference to the specification that the Examiner has misinterpreted the claim scope; or
- revise the claim scope or delete the claim to address the Examiner's concerns.

We would appreciate your comments and/or amendments (if necessary) relating the Examiner's support objection.

Item 9: Claim Conciseness

In item 9, the Examiner submits that independent claim 23 falls wholly within the scope of independent claim 16. To address this objection we recommend that claim 23 be revised such that it depends on claim 16. Please advise if this is acceptable, otherwise please let us have your comments regarding this objection.

Items 10 to 12: Novelty and Inventive Step

In items 10 to 12, the Examiner is of the opinion that the invention defined in claims 1 to 23 is not novel and/or does not involve an inventive step in light of the prior art documents D1: US 7,516,764 B1, D2: US 4,144,663 A, D3: US 5,636,669 A, D4: US 3,709,770 A, all of which were cited in the first IPRP. We note that the article 34 amendments appear to address these objections. We recommend that you review the article 34 amendments in light of the above objections, and that a revised version of the amendments be filed in response to this objection.

Entitlement to the Invention

It is important that the inventors of the invention as claimed are correctly identified, and the applicant's chain of entitlement from the inventors clearly established. If you intend to make any amendments to the claims, we recommend that you review the named inventors and advise us if any changes are needed.

Deadline for Filing a Divisional Application

If you wish to file any divisional applications please let us know when instructing us to respond to the examination report, keeping in mind that the deadline to file a divisional based on the subject application is **24 October 2018**.

The deadline of **15 July 2019** is an additional deadline which is the ultimate deadline for filing a divisional based on the filing date of the first generation application regardless of whether the application is a child, grandchild, great grandchild application, etc.

Further, it is a requirement that neither the divisional nor parent application(s) include a claim for substantially the same matter as claimed in the other application. As a result of the introduction of the new *Patents Act 2013* (to which the subject application applies), there is some uncertainty as to whether this requirement must be met on filing of the divisional application. We therefore recommend that at the time of filing of the divisional, the divisional application is filed with a single temporary claim that has no overlap in scope with the claims of its related parent application. Please keep this in mind should you wish to file a divisional application.

Substitute Pages and Electronic Editable Copy of the Specification

Since it is necessary to provide substitute pages when making amendments to both the specification and claims, it is of great assistance to us to have an editable electronic version of the specification. We therefore ask that you forward to us, if possible, an electronic version of the specification and claims in Microsoft Word® compatible format together with any arguments and/or amendments you propose to file.

Dear Tarun / Garima,

Like I had mentioned before, as it relates to the automotive industry, Eurasian IP (from the 8 countries; Armenia, Russian Federation, Belarus, Kazakhstan, Kyrgyzstan, Turkmenistan, Tajikistan, Azerbaijan) is relatively small in 'Production value' and hence 'Royalty value'. Only Russia has sizable automotive industry with an approximate 2 million vehicles manufactured per year; however, with IP rights enforcement rigor being low as per my understanding and analysis.

Given that I have borne the brunt of 'IP prosecution cost overheads due to fabricated prior art and sabotaging ISR' issued by USPTO; I want to manage my IP expenditure carefully and invest in the right IP territories. 

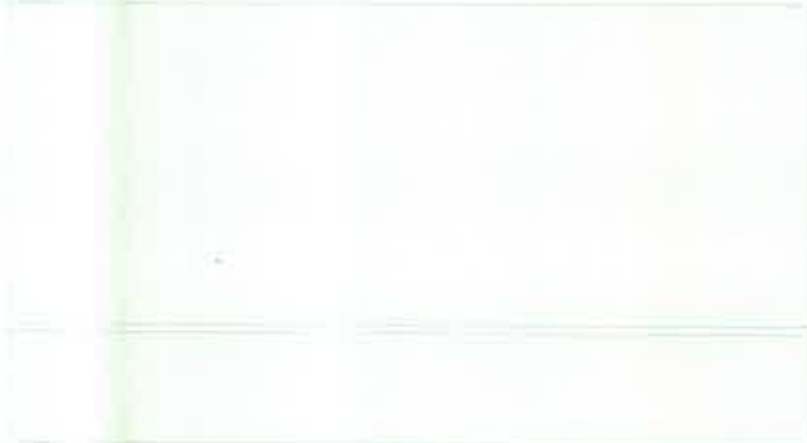

Dear Garima,

The notice periods have gone shorter from your end. I am given (near by) dates for payments. This happened for both China and Europe, which have suddenly come upon by the end of this month. I realize my account is frozen, and hence the short notices.

I do not have the funds to pay for this annuity and may have to let the application lapse, as I cannot sustain repeat office actions with the fraudulent ISR issued on PCT application.

One important question - If I were to borrow / raise debt for the funds, would you be able to accommodate the annuity payment by keeping the 4 lakhs due to your firm on the side? I am still waiting for Mr. Tarun's response if he would accommodate such a payment for China's two month extension? Let me know if you have his response?

It must be noted that both applications are related; and retaining one makes no sense. So, we must try to keep both active, or lose both.

The truth is, despite keeping these applications alive, the repeat office actions will not be sustained by me, given the financial position as outlined in the active lawsuit. Only the **'Fraud admission by defendants and USPTO sending corrected ISR to all PTO's in the World will issue a grant in these territories'**. It is expected to happen by this month end court date.
