UNDER CPC SECTION 86, READ WITH ORDER VII RULE 1 OF THE CPC, I (THE PLAINTIFF & INVENTOR) FILE THIS CASE AND MOST RESPECTFULLY SUBMIT AS FOLLOWS:

1. The address of the plaintiff and Inventor (my address) for communications is as stated above. The address of defendant for issue of summons from this Hon'ble court is as stated in the cause title above. I state that I would bear the related costs and send out the mail delivery of summons to the defendant upon the courts orders since I am appearing as party-in-person and do not have any lawyer





representing me in this suit. The defendant listed in this suit needs no introduction and here are few remarks about the defendant.

- a. **Defendant – L&T Division.** Legal & Treaties division is a division within the Ministry of External Affairs, Indian Government. They are a division that are independent to take any actions according to law and legal documents which include Treaties signed by multiple countries. In the context of my case, the Patent Cooperation Treaty, to which India is one of the contracting states.

**NOT A CONVENTIONAL PLAINTIFF VS DEFENDANTS SUIT.**

2. This is not a suit in the conventional sense of a court lawsuit, wherein Plaintiff is going against the defendant. This suit is filed so that the defendant can directly submit the 'Consent letter of the Indian central government certified in writing by a secretary to Indian government' to sue what constitutes foreign state, foreign rulers, ambassadors, and envoys.
3. The fraudulent defendant in this context is United States Patent and Trademark Office USPTO in the capacity of International Searching Authority, defendant 1 in OS 2487 of 2021 which is a lawsuit filed in this Honorable court. USPTO, has committed worldwide fraud by committing 'Breach of Patent Cooperation Treaty' Articles 18 and 19.
4. Article 18 of Patent Cooperation Treaty, titled 'The International Search Report' clause (2) reads '*The international search report shall, as soon as it has been established, be transmitted by the International Searching Authority to the applicant and the international bureau.*' Article 19 of Patent Cooperation Treaty, titled 'Amendment of the Claims before the International Bureau' clause (1) reads '*The applicant shall, after having received the international search report, be entitled to one opportunity to amend the claims of the international application by filing amendments with the international bureau within the prescribed time limit. ....*'
5. USPTO, defendant 1 in OS 2487 of 2021 has breached both the articles 18 and 19, the clause mentioned above in those articles. Additionally, OS 2487 of 2021 has defendant 3 – World Intellectual Property Organization (WIPO) International Bureau to be summoned to the court to assist the court with fact finding and discovery, by sharing factual information with this Honorable court. The lawsuit OS 2487 of 2021 also has defendant 4 – Intellectual Property India, Office of the Controller General of Patents, Designs, and Trademarks also to be summoned to the court to assist the court with fact finding and discovery, by sharing factual information with this Honorable court.
6. These three defendants 1, 3, and 4 of OS 2487 of 2021 need the 'Consent Letter of Indian central government' to be summoned to the court.
7. Over the past months, I have given the full details of the lawsuit OS 2487 of 2021 to the defendant Legal and Treaties division. I couriered a package of information



on 15-09-2021 to the defendant, and the additional secretary Mrs. Uma Sekhar has had the opportunity to review the entire lawsuit OS 2487 of 2021 and the documents attached with the lawsuit.

8. On 22-9-2021, over a telephonic conversation Mrs. Uma Sekhar confirmed to me that the 'Consent letter of the Indian government to sue defendant 1 USPTO, and summon defendant 3 – International Bureau WIPO and defendant 4 – Intellectual Property India for fact finding and verification', will be given. **This suit is filed so that she could directly hand over the 'Consent Letter of Indian government to the Honorable court through the divisions legal representation'.**

**Summary of lawsuit OS 2487 of 2021.**


