






#### Import bills of all 193 countries in Earthlings currency (Nonmoving frame of reference). No one will get cheated.

#### <u>Project Earthling© Implementation / Roll out steps:</u>

<u>Step 1</u> – The initiative must be <u>introduced at several global forums</u>, such as Economic forums, WTO, UN (UNGA), and informed to all country governments and Central banks (CB).

<u>Step 2</u> – <u>Discussions and voting</u>. The introduction would lead to discussions at many levels. Post discussions, a UN voting must be conducted, with one vote per country on the subject. This initiative will be voted in. A governing body must be established (name (e.g., GEC - Global Earthling Council), governing team (e.g., One member from each country) and other details (e.g., role, responsibility, scope of work, charter, etc.)). <u>Record opening national treasury balances of all 193 countries.</u>



    - Both Public and Private charitable Earthling Foundation Trusts will roll out series of initiatives over the next 30 years, with allocated expenditure annually for projects that must be completed within that year; to achieve 'Goal year 2050'.






