I am sending you this communication, which is already fully in public domain. Given the communication related to the upcoming 62 sale agreements, to be executed one each with each of the 62 countries, I have proactively provided direction on how I would be distributing the wealth in India in my Living Will executed on 22-08-2022.

While the wealth distribution is one thing, I have started to detail how I would be spending this wealth in India to achieve 'Goal Year 2050 for India'. This work involves a series of reforms, macro-initiatives within India over the next 30 years, which will be emulated by at least 100 or more poor countries in the world, and developing countries of the world, thus having its cascading effects to many world countries.

The 62 sale agreements would be executed with liability payment spread over 12 year period, in most of the agreements.
