**MEMO, RESPONSE TO OBJECTIONS FILED BY RESPONDENT ON
25/01/2024.**

I submit my response, to the objections, side-by-side comparison of the prayers of WP 4851/2023 with this Writ Petition.

- Prayer and the execution of 62 sale agreements, one each with each of the 62 world countries, is more legally accurate in this Writ Petition, as compared to WP 4851/2023. All 62 sale agreements to be executed as tri-party agreements.



- In annexure L of WP 4851/2023, sale agreement 2(a), was to be executed as a two-party agreement, in the local domestic currency of usa, in usd, as an interim step, with necessary approvals from RBI, to deposit usd in my bank account, and this wealth in usd exchanged to 'EARTHLINGS' with GEC, upon its organization. In this Writ petition, I refer to annexure B, sale agreement description 2(a), which is a tri-party agreement to be executed in 'EARTHLINGS' currency, subsequent to the formation of GEC. Legally all wealth brought into my bank account in Earthlings.

- Hence, I include prayer point T, to follow prayer point S, for the spin-off, and organization of 'Global Earthling Council', with representation of all 193 countries.
- I include prayer point O, that refers to annexure CC, introducing the details of 'National Wealth Bill', that must be legislated in INDIA. We must protect our 'National wealth'.
- I include prayer point P, that refers to annexure DD, introducing 'Indian Economic Council'. I, IEC, provide Macro Economic guidance for Indian Central and State Governments.
- I include prayer point FF, referring to annexure EE, for formation of 'Special Technology Unit', to counter, trace, tag, and report serum technology forming internal cage on humanity.
- I refer to alignment of this Writ petition with the PCT preamble, my intended contribution to progress of science and technology within India, described in memo filed with the Honorable court on 4/10/2023, pages 2, 3, 4, and 5. To accomplish these investments, achieve 'Goal year 30 FE for India', the wealth must be received in bank accounts in India, must be in my control, our control.
- I include prayer point C, that refers to annexure V, introducing the abuse of rouge puppet un,

run by usa, for using negative tactics, and hence taking 'New World Order' live.

- The negative tactics used by uspto, and my public enemies listed in annexure R, are several. One of which is using exorbitant bribes and forging fraudulent alliance with India. Using cutting edge technologies to apply internal and external cage at me.
 - I include prayer point X. that refers to annexure R, my public enemies and their negative tactics, using exorbitant bribes to forge illegal alliance with India to cheat 154 PCT contracting states.
 - Given the wealth to be brought to India, into my bank account, I refer to prayer point R, to appoint an all Hindu military unit for my security until 62 sale agreements are executed.

I have made this Writ petition legally much stronger and accurate, along with the additional included prayer points, most critical of them prayer point T, followed by S. This will allow us to execute the 62 tri party sale agreements with GEC, as Payor.

To bring the full wealth, at least 93 Trillion into my bank account, according to PCT article 9(1), in world neutral EARTHLINGS currency, I request that the Honorable court grant orders to all the prayer points.
