

Subject **TRANSITION INTO NEW WORLD ORDER, EXPENSES TO BE INCURRED BY WIPO, UNTIL GEC IS ORGANIZED AND FULLY OPERATIONAL IN ITS OWN FACILITY, ASSEMBLY, AND YOUR DIRECT FINANCING AGREEMENT IS ESTABLISHED WITH GEC, ACCORDING TO COMMUNICATION DATED 24-4-2024, MUST BE TRACKED IN A SEPARATE EXPENSE ACCOUNT CODE.**

After our combined endeavour to take the MACRO ECONOMIC REFORM PROJECT EARTHLING© live, our work to transition the world into NEW WORLD ORDER would include more expenses for World Intellectual Property Organization, in CHF currency in Switzerland, until we achieve the following.

- Global Earthling Council, GEC is fully operational in their own facility, start to meet and work in their own GEC assembly facility.
- The leadership team of GEC is fully established. The EARTHLING currency bills are designed, printed, in required amounts, and volume.
- The GEC team of designated signatories are executing agreements for GEC. They have the Digital, and Document storage capability at their own facility.
- WIPO, has established itself as New World Order council, INTELLECT COUNCIL, and has established the direct financing agreement with GEC, in line with communication dated 24-4-2024.

While we get to the completion of these listed objectives, there will be Transition work, that we must take up, and pay expenses for, which include,

- Temporarily using the WIPO assembly as the GEC assembly, with 193 countries nominating their delegates for GEC. A transition schedule, calendar change to allow the GEC delegations to meet at WIPO assembly, for few days a month.
- All the time spent, facility used of WIPO IB during this transition, until GEC starts working off their own facilities. GEC facility, and assembly to be built in India.
- Transition activities include giving qualification, profile description of delegation leadership team to the 193 world countries.
- Transition activities might also include introducing the full details of New World Order councils, their organizational structure details to 193 country delegates at WIPO assembly. I will present the details of locations where each of the council head offices, assemblies will be established while introducing the New World Order councils.

In this communication, I request that you open an 'EXPENSE ACCOUNT', marked with a special code that indicates, 'EXPENSES INCURRED TO TRANSITION THE WORLD INTO NEW WORLD ORDER, AND GETTING GEC ON ITS FEET, FULLY OPERATIONAL', and do the necessary spend of money in CHF against this expense account, special code, and cumulate it across months. This Expense account should also be used until WIPO, rebrands itself as a New World Order council, INTELLECT COUNCIL, IB International Bureau, and is fully functioning as a New World Order council.

This expense account, accounts for all your expenses that are excluding the LEGAL expenses to eliminate the breach of PCT, mentioned in earlier communication, and all your incurred expenses in transitioning into New World Order, the expenses not covered by your direct financing agreement. For this expense account, we must consciously make efforts to keep any and all foreign expenses, non CHF, outside Switzerland, to be very relevant and required. While GEC once fully operational in a facility can make decisions to relocate the facility, or follow through with their expansion plan across world countries, there will be expenses from INDIA, where the first GEC assembly facility, and the mint would be established. GEC will operate from INDIA and the mint to print Earthlings will also be established in INDIA which will be under 24 by 365 surveillance. The expenses could be tracked under separate codes, for INR expenses in INDIA, and other currency expenses that are non Switzerland, and non India. All expenses are subject to audit by GEC prior to the payment.

The New World Order councils will be spread across Asia, Africa, and Europe, with regional and national offices of some councils reaching all the world countries, excluding usa and uk. All these expenses logged against this expense account to be reimbursed by GEC as a one time, 'Transition into New World Order' expense payout in Earthlings currency. You might be in Earthlings surplus that must be adjusted across CHF, to get fully into operational mode Intellect Council.
