The Honorable High court of Karnataka pronounced the orders and issued the following orders, for WP 12356/2023. The orders are attached with this communication. The Honorable court 'ALLOWED' the 'cause of action', breach of PCT articles 18(2) and 19(1) committed by US PTO on 5-8-2015, in their capacity of International Searching Authority, ISA, for my invention PCT international application PCT/us2014/046619 filed on 15-7-2014, taking priority of my invention priority application 14/227,859 filed on priority filing date 27-3-2014, which is a patent grant 'us 8,910,998 B1' with a patent date of 16-12-2014.
