NEWS UPDATE

To, All INDIA Media Houses, Publishing and Broadcasting,

I bring your attention to the orders of the Honorable High court of Karnataka, dated 14-6-2024, for Writ Petition, WP 12356 of 2023, wherein, from all the documented evidence I have submitted to the Honorable court, they have 'ALLOWED' the cause of action, that United States Patent and Trademark Office breached Patent Cooperation Treaty articles 18(2), and 19(1) on 5-8-2015, by issuing fabricated International Search Report, for my invention 'Systems and Methods for altering the color, appearance, or feel of a Vehicle Surface', PCT International Application PCT/us2014/046619, filed on 15-7-2014, by taking priority of priority patent application 14/227,859 filed on 27-3-2014, which was issued a patent grant 'us 8,910,998 B1' on patent date 16-12-2014. These orders are attached as document 1. Now that the Honorable court has recognized this 'cause of action', with the documented evidence the Honorable court would provide necessary Direction, and issue necessary orders to take this 'cause of action' to its full LEGAL RESOLUTION, which is by issuing orders for executing 62 sale agreements, one each with each of the 62 countries where I have enforceable patent rights for my invention according to law and Patent Cooperation Treaty.

Patent and Trademark Offices are independently run by appointed Directors, Controllers and they are considered as Government agencies by the Honorable court, mutatis mutandis by Honorable Judiciary across the World countries. These Directors, Controllers report to their respective country Government Leaders, Prime Ministers, or Presidents. Hence, the 62 sale agreements, will be executed by the Leaders of the 62 countries, upon the coordination for the execution of these agreements by the Respondent Legal and Treaties Division, of the Ministry of External Affairs, upon the orders of the Honorable court. I have sent a communication attaching the Honorable court orders, to the 61 country Patent and Trademark Offices, Directors, Controllers. This communication would have certainly reached their respective country Leaders, Prime Ministers, or Presidents. This communication is attached as document 2.

As of this date, 157 World countries have signed Patent Cooperation Treaty, a LEGAL AGREEMENT, the most popular Treaty across the World. Its preamble provides for 'contributing to the progress of science and technology' which is an objective of all 157 World countries. In line with the PCT preamble, from this wealth receipt, I will make significant contributions to the progress of Science and Technology in INDIA. According to PCT article 9(1), the wealth from these 62 sale agreements, the sale proceeds must be received by me in my bank account in INDIA. To enable this, I authored Macro Economic Reform Project Earthling©. I will introduce this reform to 193 World country delegates at an upcoming World Intellectual Property Organization, WIPO assembly upon Honorable court orders. Authored information about Project Earthling©, relevant website weblinks to read from are listed in document 4.

The list of 62 sale agreements is attached as document 3. These will be executed in the Honorable High Court of Karnataka, upon the Honorable courts orders.
