From the Press conference conducted at Press club Bangalore on 18-10-2024, here is the 'Press release about the 'LEGAL FACTS AND LEGAL DOCUMENTS' related to the transformative patented invention 'Systems and Methods for altering the color, appearance, or feel of a Vehicle surface', PCT/us2014/046619, and the other sector applications of the same invention 'Systems and Methods' PCT/IB2016/050993, PCT/IB2016/050994, and PCT/IB2016/050995, all four Invention 'Systems and Methods' recognized and filed under the provisions of Patent Cooperation Treaty'. This 'Press release' includes the following 'LEGAL FACTS AND LEGAL DOCUMENTS' attached in this sequence.

All these LEGAL DOCUMENTS, are in the possession of the Honorable court, and all the LEGAL FACTS are recognized by the Honorable court, by way of annexures attached in the Writ Petitions WP 12356/2023, and WP 13823/2023, combined, the Honorable court recognized the 'cause of action', Breach of Patent Cooperation Treaty articles 18(2) and 19(1) committed by US PTO on 5-8-2015, in their capacity of ISA, International Searching Authority, for Patented invention PCT/us2014/046619, which is claiming priority of priority invention patent application 14/227,859 filed on 27-3-2014, which is issued a patent grant on 16-12-2024, with patent number us 8,910,998 B1. By way of the WIPO publications WO/2015/147900, WO/2017/144949, WO/2017/144948, and WO/2017/144950, all the LEGAL DOCUMENTS are published, and recognized as documented evidence by the Honorable court, proving the Breach of PCT committed by US PTO beyond reasonable doubt. Hence the Honorable court has 'Allowed' the 'cause of action' by issuing orders dated 14-6-2024 for WP 12356/2024. The Follow through sequential directions, orders for the execution of 62 sale agreements were included in WP 13823/2023, which is currently WA 983/2024 posted for 'ORDERS' in the Honorable court.

This 'Press release' includes the following 'LEGAL FACTS AND LEGAL DOCUMENTS' attached in this sequence. In these documents you might see annexure tags, page numbers, notary seals identifying annexures, which you could ignore, since these are document prints of court submissions.

- The breach of PCT articles 18(2) and 19(1) committed by US PTO, clearly indicated on the PCT Timeline. The PCT Timeline is accessible at WIPO.int website in FAQ'S section.

- Details about how all four PCT International invention sector applications are connected. The International Search Reports, ISR'S, clearly indicate that they are the same inventive 'Systems and Methods', by rejecting the claims with priority patent us 8,910,998 B1.

- Graphical representation of 'the exemplary Thermal insulation application claims PCT/IB2016/050994 estimated 'Energy savings' data for one country usa, over a 100 year timeline', shown with two different currency depreciation factors. When the 'Energy Savings' are extrapolated to all 62 World countries, the cumulated 'Energy Savings' shoots up the sale price to extremely high numbers.

- Photocopies of the 'International Search Reports', ISR'S issued by ISA, INDIA Patent and Trademark office, for the three other sector inventions PCT/IB2016/050993, PCT/IB2016/050994, and PCT/IB2016/050995, rejecting the claims with priority patent us 8,910,998 B1.

- Extracts from Patent Cooperation Treaty, including PCT preamble, and PCT articles 9, 55, 16, 18, and 19.
