

I draw the attention of the Honorable court, to a negative tactic 'Data center LEVER', used by rouge US PTO, as a last roll of dice to attack me, by buying INDIAN Hosting company that is hosting my data, information, e-mail accounts, and websites since year 2019.

- I referred to the website weblink <https://srinivasdevathi.com/writ-petition-for-execution-of-62-saleagreements/>, in the Writ Appeal providing access to WP 13823 of 2023, and all the Memos filed with the WP. The website SrinivasDevathi.com was hosted by an all INDIA data center and hosting services company, when I used their services for hosting all my websites, e-mail accounts in 2019. This was with the intent to have a PATRIOTIC INDIAN ALL HINDU company, hosting services company to host the websites and e-mail accounts, given that I would execute the 62 sale agreements upon the orders of the Honorable court.



- Between 2014 and 2019, the year when I migrated all my information, e-mail accounts, and websites to the all INDIA hosting services company, I used the services of a rouge usa hosting company godaddy.com, which was controlled, and used to manipulate my information, by my public enemy US PTO. Their intent was to control my Invention, and if possible block the wealth I would bring to INDIA, into my bank account in INDIA. My public enemies have attempted to use the hosting services companies as a method to attack me, my work, and information.
- Unfortunately, the INDIAN hosting services company, from their own revelation, and media information, was acquired by 'World host group', that they claim is headquartered in rouge uk, with offices in rouge usa, possibly fully controlled by rouge usa.
- This acquisition according to media source is dated Q2 of 2023 with report dated August 2023. The acquired INDIA office is now a captive center, order taking branch office, which is getting orders from my public enemies US PTO, through the host group.
- Over the last couple months, I had an issue with my hosted account, wherein a hacking event caused loss of some e-mails from the e-mail account [ProjectEarthling@SrinivasDevathi.com](mailto:ProjectEarthling@SrinivasDevathi.com). They also fail to recover the account giving random reasons.
- It is clear that the INDIAN hosting company was bought by rouge uk world host group, since I was their client, they gave orders to disrupt my account and cause the loss of e-mails. Given this, they are not reliable as an INDIAN patriotic HINDU hosting company.
- Hence, prayer point Q, for the Honorable court to issue orders, wherein I could at least back up all the information, data, that I must author for the introduction of the Macro Transformations at WIPO assembly, addressing 193 country delegations.
- The Macro Economic Reform 'Project Earthling©' will put an end to all abusive Levers used by rouge US PTO, rouge usa, rouge uk, and rouge old world order, by decentralizing the world, ending the concept of mnc, and allow registered companies, in one country to have business or trade agreements, with other countries by way of 'Trade or Business agreements executed in World neutral currency EARTHLINGS', the transaction conducted through



'International Trade and Business Banks, ITB Banks'. All Levers including 'Data center Lever' will be terminated.

- I intend to appraise the acquired INDIAN hosting services company, India CEO, about this, and ensure INDIA'S National security and Economic security are protected and not jeopardized from foreign country orders. I will keep the Honorable court informed. Similarly, mutatis mutandis, several companies in INDIA, organizations that sold products, or deliver services to me are being controlled, manipulated, ordered, bribed, to steal my information, attack me, control me, or work against the execution of 62 sale agreements. I will keep the Honorable court informed.
