**For Memo filed on 23-9-2024, under order VI, rule 17 of CPC. That the Memo should be an IA. Here are the Legal options provided.**

- I filed this memo, to immediately receive 'Interim relief' orders for investigation related prayer points, since the investigation must be conducted at the earliest, by keeping prayer O pending, for receipt of the 'Consent Letter'.

- This was with reference to the 'combination of orders issued by the Honorable court for WP 12356/2023, and PATENT COPERTION TREATY, the breached legal agreement binding 157 World countries'.

- The 'Consent Letter' was due by 14-12-2024, and I am yet to receive it from the respondent.

- Once the Honorable court lists this WA 983/2024, the respondent will provide status to the Honorable court.

- Until then, by taking into consideration, the details related to urgency for granting interim relief orders, described in this 'Written Statement', this memo filed on 23-9-2024 may be allowed, without it having to be converted to an 'IA', since the Prayer points are exactly the same.



- I am willing to withdraw this memo, upon receipt of the 'Consent Letter' if the Honorable court allows the same, reverting to the Prayer filed in the Writ Appeal memo, since the prayer points are exactly the same, and the restrictive clause of receipt of 'Consent Letter' is satisfied.

Remarks about the documents attached. Since this is a 'Written Statement' filed with WA Pending branch, I have attached Document 9, true copy without Notary attestation. The bank statement attached with Document 11, is computer generated, and is also filed without Notary attestation.

I must file one memo per year in this Writ Appeal, including addendums filed at end of each year until 2034, for conclusion of the 'Wealth Distribution' from the 'Wealth Receipts' into my Individual ITB Bank INDIA, Bank account. I request the Honorable Court to allow this memo filing per year, without it being marked as an IA.

#### COURT FEES

With reference to WP 13823/2023, I was only able to introduce certain filing receipts of PCT International applications, my remittances, lawyer invoices, and filing receipts from PCT/us2014/046619, 15 National and 2 Regional applications. I never had time for walking through the prayer points individually.

I request the Honorable Chief Justice, to evaluate the applicable court fees for 'Liability claim' caused to US PTO, the valuation of 62 sale agreements cumulated total, which I shall pay upon Liability receipt, and allocate enough and reasonable time for hearing, such that I get to speak, and grant the Interim Prayer relief.



With reference to Document 10, status of 15 National and 2 Regional applications.

With PCT/us2014/046619, I filed a total of 15 National and 2 Regional applications. Most of the Patent and Trademark Offices, from across the PCT contracting states, refer to the 'International Search Report', ISR, issued by the chosen 'International Searching Authority', ISA.

In Document 10, I attach the 'Patent and Trademark Office responses / reports' from the PTO'S of Australia, China, Eurasian EAPO, European EPO, India, Japan, South Korea, and New Zealand, listed alphabetically, all of them citing the fabricated prior art from the fabricated ISR issued by US PTO.

This is clearly the caused liability for the ISA, US PTO, that issued the fabricated ISR. All these 8 PTO'S including the 2 Regional PTO'S, referred to the fabricated ISR, and issued their office action responses and reports. Even in the reports issued in local languages, we can observe the fabricated serial numbers.

Nigeria PTO issued a patent grant, since they recognized the fraud committed by US PTO. I include the annuity payment details in document 11. South Africa PTO had granted a patent similarly. However, the granted patent lapsed for non payment of annuity, given my outstanding debt, not able to pay for lawyer fees.

The other National applications which include Canada, Mexico, Brazil, Thailand, Philippines, Malaysia, and Indonesia, their Patent and Trademark Offices were yet to issue their 'Office response / report', when they were abandoned, due to my debt, not able to pay applicable annuity fees.

Given these facts, I am the APPLICANT according to PCT article 9(1), and I am the only recipient of the Liability into my bank account in INDIA, and further receive the Liability in World Neutral currency EARTHLINGS, into my 'Individual' bank account in, International Trade and Business Bank, ITB Bank INDIA.

Introduction of Macro Economic Reform Project EARTHLING©.

I conducted a 'Press conference at Press Club of Bangalore', on 18-12-2024, where for the first time, over 90 minutes, I presented 'Preliminary Introduction of the Macro Economic Reform Project Earthling©, to INDIA Media houses', a press release, attached Document 12, distributed to Worldwide Media houses.

In summary, I look forward to the introduction of this 'Macro Economic Reform', upon the Honorable court orders, at World Intellectual Property Organization assembly, addressing all 193 World country delegations, in the '24 HOURS INTRODUCTION EVENT'.



INDIA citizen Fundamental Rights, and Fundamental Duties.

My fundamental Right and Fundamental Duties, and denied and blocked respectively by US PTO. Article 21 of the constitution of INDIA, provides that 'Right of privacy is a Fundamental Right'. US PTO is invading my privacy and continue to do so, and hence the urgency in investigation prayer point orders.

I performed my 'Fundamental Duty' by pledging 90% of wealth for INDIA, with my contribution according to Annexure E of WA 983/2024, for achieving 'Goal year 30 FE for INDIA', which will have cascading effects, and replicating effects to 187 other World countries.

Relevant clause within Article 51A include,

- (d) to defend the country and render national service when called upon to do so;
- (g) to protect and improve the natural environment including forests, lakes, rivers and wild life, and to have compassion for living creatures;
- (h) to develop the scientific temper, humanism, and the spirit of inquiry and reform;
- (j) to strive towards excellence in all spheres of individual and collective activity so that the nation constantly rises to higher levels of endeavour and achievement.

INDIA current day law enforcement capability or lack of it.

In INDIA, the scientific and technological capability for identifying, tracing, dismantling, and tagging as evidence for the Honorable court, usage of External cage used against target subjects, by electronically surrounding their rooms, houses, offices, and car/vehicle, is non existent.

In INDIA, the scientific and technological capability for identifying, tracing, defining the molecular structure / chemical formula, and tagging as evidence for the Honorable court, usage of Internal cage used against all human organs by using advanced serum technology, is non existent.

In INDIA, the scientific and technological capability for identifying, tracing, defining the molecular structure / chemical formula, and tagging as evidence for the Honorable court, usage of Brain cage used against all regions of human brain by using advanced serum technology, is non existent.

In INDIA, the scientific and technological capability for recognizing, dismantling, reporting, and tagging as evidence for the Honorable court, usage of the Life cage, combination of Internal, Brain, and External cages used against target subjects, is non existent.

PCT Preamble

The legal agreement that is breached, PATENT COOPERATION TREATY has provisions for 'contribution to the progress of science and technology', and to build the necessary 'Scientific and technological capability' in INDIA, I will invest and organize Special Technology Unit, to report and terminate all forms of cages.

Detailed reading and examination of FOUR YEAR MACRO PROGRAM.

This WA is connected with 157 World countries by way of PCT, all 193 countries because of my authored Macro Economic Reform Project Earthling©, and 62 World countries directly with my 'Invention Systems and Methods' patent rights, resulting in this Writ Appeal being 'a connected to entire world' Writ Appeal.
