

**MY WRITTEN STATEMENT FOR OFFICE OBJECTIONS**

I submit the following 'chronological sequence of events' for my LEGAL STATEMENT.

Date	Event
1-7-2024	I filed the Writ Appeal WA 983/2024 with the Honorable High court of Karnataka.
9-7-2024	I filed the 'Memo, enclosing a copy of Writ Petition WP 13823/2023, with all annexures, and statement of objections filed by respondent'.
31-7-2024	The Honorable court dispensed the office objections.
6-8-2024	The Honorable court issued order to give a full copy of WP 13823/2023, entire compilation to the respondent.
9-8-2024	I left a copy of Memo filed with the Honorable court on 9-7-2024, 'Memo, enclosing a copy of Writ Petition WP 13823/2023, with all annexures, and statement of objections filed by respondent', for Respondent at ASG Office at the High court of Karnataka. After giving the copy, I called the respondent advocate Mr. Shivaprasad Shantanagouder and requested that they collect the entire memo copy, and he obliged.
20-11-2024	The Respondent advocates walked in with the full copy of the WP 13823/2023, and also cited several annexures, Prayer points, and related page numbers from the copy of WP 13823/2023, during the one hour court hearing in afternoon. Erroneously, the court copy of the Memo is brought into the court for the first time, this afternoon. The Honorable court issued orders that read '..... On enquiry, Registry today placed memo dated 09.07.2024 and documents submitted. Therefore office objection does not survive for consideration and the order dated 04.11.2024 is recalled. Registrar (Judicial) is requested to look into the matter and take action against the concerned officials.....'.
16-12-2024	I didn't remove or include new pages in court copies of the WA, and court copies of the WP in memo filed on 9-7-2024, outside of the

The hand written corrections, in accordance with the orders of the Honorable court dated 20-11-2024, were only the following.</p> <ul style="list-style-type: none"> <li>- The WP number was hand written in the four volumes of the WP 13823/2023 in memo filed on 9-7-2024, in both the court copies.</li> <li>- The Prayer in the WA was preceeded with hand written text '<u>By setting aside the impugned orders for WP 13823/2023, dated 14-6-2024,</u>', in both the court copies. The same hand written text was included in the Memo filed under order VI, rule 17 of CPC, on 23-9-2024, preceeding the Prayer, in both the court copies.</li> </ul>

### **LEGAL STATEMENT**

The Honorable Chief Justice, for Honorable court dispensed all the office objections, with orders issued on date 31-7-2024. These orders persist through the subsequent events.

For Memo filed on 23-9-2024, under order VI, rule 17 of CPC. That the Memo should be an IA. Here are the Legal options provided.

- I filed this memo, to immediately receive 'Interim relief' orders for investigation related prayer points, since the investigation must be conducted at the earliest, by keeping prayer O pending, for receipt of the 'Consent Letter'.

- This is with reference to the 'combination of orders issued by the Honorable court for WP 12356/2023, and PATENT COPERTION TREATY, the breached legal agreement binding 157 World countries'.

- The 'Consent Letter' was due by 14-12-2024, and I am yet to receive it from the respondent.

- Once the Honorable court lists this WA 983/2024, the respondent will provide status to the Honorable court.

- Until then, by taking into consideration, the details related to urgency for granting interim relief for investigation described in the accompanying 'Written Statement for the erroneously issued / changed party in person committee report', this memo filed on 23-9-2024 may be allowed, without it having to be converted to an 'IA', since the Prayer points are exactly the same.

- I am willing to withdraw this memo, upon receipt of the 'Consent Letter' if the Honorable court allows the same, reverting to the Prayer filed in the Writ Appeal memo, since the prayer points are exactly the same, and the restrictive clause of receipt of 'Consent Letter' is satisfied.

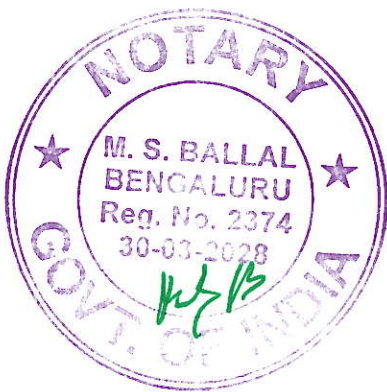
