RESPONSE TO 'OBJECTIONS FILED BY RESPONDENT 3 ON 1-3-2025'.

1) I present the following legal facts.

- The Honorable court has recognized the 'Breach of Patent Cooperation Treaty', a treaty signed by 157 World countries, breach committed by 'united states patent and trademark office'.
- The recognized breach of Patent Cooperation Treaty, is clearly indicated in orders issued by the Honorable court for WP 12356/2023, dated 14-6-2024.
- The legal resolution of this recognized 'cause of action', is by way of issuing orders for the execution of 62 sale agreements attached as Annexure B with this Writ Petition.
- The attached Annexure A1, includes the four years projected events for getting these 62 sale agreements executed. The critical path step is the organization of 'EARTHLINGS COUNCIL', EC, and organizing the team of designated signatories for EC. These steps are introduced and described in the four years projected events.
- I attach Annexures A2, and A3, indicating that the 'Four years projected events Macro Program' is officially with the World Intellectual Property Organization and the 61 World country PTO'S. The 'Four years projected events Macro Program' is part of all the attachments in annexures A2 and A3. All the attachments in the e-mail communications are not included in the annexures, due to the documents size, and can be produced upon request.

- Respondent 1 in this WP is yet to issue the 'Consent letter' according to orders issued to them by the Honorable court on 14-6-2024, with due date for issuing the 'Consent letter', 14-12-2024.
- I expect to receive the 'Consent letter' in the immediate future. I present the status of Writ Appeal 983/2024. Respondent 1 in this WP is asked to answer the Honorable court in WA 983/2024, which was listed on 8-4-2025, and is listed for orders on 22-4-2025.
- I attach Annexure A4, communication written to PCT Infoline, where they indicate the procedure for updating my information, for 2 patents, 13 National patent applications, and 2 Regional patent applications, with the corresponding 17 PTO'S, which provide patent rights protection across 61 World countries, wherein the information update includes updating my mobile number '9663932293' issued by respondent 3. The phone number for reaching me, for all 17 PTO'S, 61 World countries, World Intellectual Property Organization, International Bureau, is 9663932293, issued by respondent 3, for which they are yet to accurately reflect my address, and e-mail ID information. The activities to update my information across 2 patents, 13 National patent applications, and 2 Regional patent applications, is initiated and is in progress.
- Registrar Judicial of this Honorable court, stated that the listing of WA 983/2024, court dates, would be sent to the mobile number and e-mail ID mentioned in the file. The 'Identity theft', or 'alias' connected with the mobile number issued by respondent 3, '9663932293' is the listed mobile number, and e-mail ID 'ProjectEarthling@SrinivasDevathi.com' hosted by respondent 2, are my contact information listed in WA 983/2024. The orders in this Writ Petition will enable termination of 'Identity theft', and 'alias' attempts, and the court would recognize my mobile number and e-mail ID as officially, truly connected with me. Mutatis mutandis, the orders in this Writ Petition, would enable International Bureau, World Intellectual Property Organization, and 61 World country PTO'S to recognize my mobile number and e-mail ID as officially, truly connected with me. They will freely correspond with me, the real applicant according to PCT article 9(1).

For these legal factors listed, with reference to the annexures attached, and annexures F, G, and H, I request the Honorable court, to issue orders,

3) Other remarks about the objections filed by respondent 3.

My interim prayer is basic service level relief, which is accurately reflecting my information, address, and e-mail ID for the mobile phone line

'9663932293' issued by respondent 3. This will terminate the negative tactic of 'Identity theft', and possibility of 'Alias' representation of me, to receive wealth by taking my place, which is against the law, against Patent Cooperation Treaty, directly breaching PCT article 9(1), which reads 'Any resident or national of a Contracting State may file an international application.'. The Honorable court has my Identification documents on record, I am National of INDIA and resident of INDIA, and the Applicant according to PCT article 9(1). So, all agreements, must be signed by me, and liability paid into my bank account in INDIA. Respondent 3 must update my information accurately terminating others from attempting Identity theft or Alias, taking my place.

According to Annexure A1, for these FOUR YEARS, I shall DIRECT AND LEAD these projected events with full support and coordination from the Honorable court, and World Intellectual Property Organization. During these four years, until the conclusion of the execution of the 62 sale agreements, respondent 3 might receive requests to work against me, and they can cite LAW, Honorable court orders which will enable them not to succumb to residual rouge old world order pressure to block wealth from coming to my bank account in INDIA. With fearless NATIONALISM, and fearless PATRIOTISM, for legal remediation of the 'cause of action' and to bring the wealth into my bank account in INDIA, according to PCT article 9(1), National of INDIA, Honorable court must dismiss objections filed by respondent 3, and issue the prayed orders. If respondent 3 adhered to the guidelines and notifications of DOT, and regulations of TRAI, why is my address not accurately reflected, when I gave my ID proof document copy while procuring the phone line '9663932293'? If it was accurately captured at the time of issue, how did

it change, and who changed it? These are questions respondent 3 must answer the Honorable court.

Identity theft, and 'alias' attempts must be terminated. My call with PCT Infoline, WIPO, they verify my identification by simple questioning, to ensure that they are speaking to me, since my address does not match with phone number issued by respondent 3, and I have filed this Writ Petition. In Annexure A4, I attach communication response of PCT Infoline, for updating my information across 2 patents, 13 National patent applications, and 2 Regional patent applications, wherein I am using the mobile number issued by respondent 3, '9663932293' for all future communications with 61 country PTO'S, International Bureau, and World Intellectual Property Organization. Incorrect information, will become a question, an element of doubt, for 61 PTO'S and WIPO, while they are communicating with me, the REAL APPLICANT according to PCT article 9(1). Hence respondent 3 objections must be dismissed, and prayer orders granted.

For Writ Petition rules do not apply for private companies. The 'cause of action' remediation is by the Honorable court orders for Respondent 1 in this Writ Petition, wherein the remediatory action, includes execution of 62 sale agreements, follow through with the attached annexure A1 activities, FOUR YEARS projected events, during which time, respondent 3, must support the Honorable court, by providing necessary fearless, high quality services, so that I sign the 62 sale agreements without service outages, or other attempts of 'Identity theft', 'Alias', to steal my wealth.
