LEGAL REMARKS.

I have executed, and legalized a LIVING WILL for 93 Trillion Earthlings wealth coming to me and to INDIA by the sale of my invention and execution of 62 sale agreements described in annexure D. The Living Will has language built into it, which ensures the percentage distribution to the recipients shall stay the same, despite a sale price RESET to a value greater than 93 Trillion Earthlings, by the independent valuation of Respondent, INDIA Government, or participation of 193 countries. A notarized and attested true copy of Living Will Executed on 22-8-2022 is attached with this annexure in

this Writ Appeal. I draw the attention of the Honorable court to the expiry date of this Living Will, which is 31-12-2034, by which date I intend to distribute the wealth of at least 93 Trillion Earthlings to all the intended recipients in the Living Will.

- 25 out of 62 sale agreements will be executed with a one-time single payment plan built into it, and the other sale agreements will be executed with payment plan spanning from the year of agreement execution until year 2034. In this annexure, I include the Living Will Addendum for Year Ending 2024' executed on 29-12-2024. The addendum indicates the 'Wealth receipts' and 'Wealth distribution to the intended recipients', and includes an enclosure with definitions for Project Earthling©, ITB Bank, Treasury banks, IEC, New world Order, and TRAW. It also includes the 'Projected schedule of events slides for four years, a timeline', in which this Writ Appeal must be considered replacing the referred writ appeal. I will be executing 10 more 'Living Will Addendums' at the end of each of the 10 years, 2025 to 2034, indicating the annual statistics, annual incremental statistics of the Wealth receipts' and Wealth contribution to the intended recipients'. Living Will Addendum is not going to be a registered document. I will publish the addendums annually at my website SrinivasDevathi.com. Upon Honorable courts orders, respondent to give official formal communication addresses, key contacts information, e-mail ID'S, and direct telephone numbers of all the recipients mentioned in the Living Will. Subsequent to the execution of the 62 sale agreements through the orders of this Honorable court, if the court retains the Writ Appeal in Pending status, I will conclude the distribution of wealth to the intended recipients through the Honorable court, by end of year 2034. According to the Living Will executed on 22-8-2022, I have pledged 90%
- According to the Living Will executed on 22-8-2022, I have pledged 90% of the wealth for a visionary goal 'Goal year 2050 for India', also referred as 'Goal year 30 FE for INDIA', to ensure India achieves all the economic goals. By way of cascading effects of 'Goal year 30 FE for INDIA', Macro Economic guidance and direction will follow through, and replicate into the economies of all 187 world countries, including the at least 100 or more poor and developing countries of the world.

LEGAL FACTS

I present the following legal facts to the Honorable court, aligned with the executed Living Will.

- Intellectual property is ones own. In this context, my invention patent, and the worldwide patent rights according to PCT article 9(1) are owned by me, the liability for the loss of which is payable to me, into my bank account in INDIA. Intellectual property rights, in this context patent rights, cannot be inherited upwards in the family tree, by my ancestors, including my father and mother. Intellectual property rights, in this context patent rights, cannot be inherited laterally in the family tree, by my siblings. Intellectual property rights, in this context patent rights, can be inherited downwards in the family tree, by spouse and children.
- My divorce with Vindhya Yalmuri concluded on 25-7-2012. I attach a copy of my divorce decree showing the date of disposal of our marriage, 25-7-2012, and a copy of the one time full and final settlement 'Mediation report', dated 25-7-2012, in the Family court at Bangalore, for M. C. No. 1014/2011. With my divorce with Vindhya Yalmuri concluded on 25-7-2012, with us having no children from the marriage, there are no legal heirs to inherit my wealth from the concluded marriage.
- related to the wealth I bring into my bank account in INDIA, from the execution of the 62 sale agreements, connected with my Living Will executed on 22-8-2022. My father Mr. D. Satyanarayana died on 1-1-2018, and could not have executed any documents representing me. Investigation prayed in this Writ Appeal, with reference to annexure H will conclude no negative tactics were used by my public enemies to steal any of my wealth, or patent rights in any territories from me.
- My mother Mrs. D. S. Premaleela, whose aadhar card copy is attached with this annexure lives at my residential address, and she cannot represent me or inherit any of my wealth received from my invention patents. I handed over a copy of the Living Will to my mother, and she has retained the copy for her record. While this is the Legal step, she is in receipt of the Living Will, my mother cannot read english and has minimal understanding of the contents in the Living Will. She however has the overall understanding that I have an invention and I am about to receive liability payment. I shall speak for her, with regards to my invention, patent, wealth, and all legal subjects.
- I attach an e-mail communication dated 23-2-2024, sent to my siblings, sisters, Mrs Sridevi Devathi, and Mrs. Shirisha Mohan, directing them to my Living Will published at my website. This has given them legal

clarity about my wealth that would be brought into my bank account in INDIA by the execution of 62 sale agreements upon the orders of the Honorable court. This communication is legal communication for my sisters and their legal heirs. I also hand delivered copies of my Living Will to my sisters, for their record.

- For the record of the Honorable court, my father, my mother, my sisters, do not have knowledge about inventions, patents, intellectual property, Patent Cooperation Treaty, PCT Timeline, PCT procedures, Economics, business, Automotive industry, design, manufacturing, production plant assembly line, Macro Economics, Patent sale price estimations or valuations, and their ignorance could be exploited.
- I request the Honorable court to record that I have never visited a 'Sperm bank', and hence have never made 'Sperm donation'. This statement is applicable for all 193 world countries. No one can claim they are my legal heirs. Fraudulent usa citizens or uk citizens might attempt to use negative tactic, of inheritance claim coming to Judicial courts in INDIA. Such attempts are frivolous and fabricated lies.
- I also attach a brochure about the cascading effects of my work within INDIA, for achieving 'Goal year 2050 for INDIA', referred in the Living Will. This goal, also referred as 'Goal year 30 FE for INDIA', will be achieved by me by launching a series of transformative initiatives over the 30 year period, launched through Earthling Foundations Public charitable Trust, Earthling Foundations Private Trust, and by way of 'IEC, Indian Economic Council' initiatives, which would be advisory to Indian Central and State Governments, Union Territories, all from the contributions of the wealth I receive from the execution of 62 sale agreements.
- The cascading effects of these initiatives will reach most of the world countries, certainly the 100 poor countries of the world, given the replicable, and emulatable effects of the initiatives, and the Macro guidance, they receive through the New World Order unbiased councils.

- 10% of this 93 Trillion Earthlings / \$ wealth will be 'My personal wealth' in my personal bank account and spent on my personal expenses and select personal projects across India.



The first step towards a balanced world and more equality.

This initiative brings about more trade and economic equality.

This is the most important reform required to global economic situation as it stands today.

Problem Definition: The current global trade situation is as given below.

1) All global trade is predominantly done in USD.

2) All the important global trade commodities are priced in USD.

3) And it is the currency of one country - USA.

This has resulted in global trade commodities being subjected to fluctuations based on two moving (varying) frames of reference. The USD strengthens or weakens based on its demand and other factors. The commodity price fluctuates based on its demand and supply.

Secondly, global trade between countries (import / export) and forex transactions happen in so many different currency exchanges. This allowed USA to become a 'Mint based economy'; to print as much as they want and inject into the global trade system, with no checks or balances of any kind for themselves or their country's GDP numbers. It is evident in:

a) The military arms / weapons stockpile they have amassed over decades. The fire power is enough to destroy earth. Their military is stationed in so many countries, despite the costs involved.

b) The number of wars they have waged across the globe and yet with no dent to their economic condition, when you factor in the military and war expenses.

c) The standard method of bailing out all Corporations / Banks in USA by injecting money into the system. E.g., 2007-2008 Credit crisis due to Housing bubble burst; they bailed out all banks by printing money.

d) Most of the USA Corporations are bloated with surplus funds and cash, because of available credit, as Banks could be bailed out anytime.

Should the World continue to deal with this imbalance on Planet Earth? Should USA continue to dominate and in doing so, block all other countries growth prospects and development opportunities?

l, as Indian citizen realized that such a global environment is not conducive for India to become a developed country. This needs correction, if the aspirations of 1.32 Billion Indian citizens must be met and realized. Since this is a global problem, the same thought applies to every non-USA country. I personally am interested in making India a developed country by year 2050 (Goal year 2050).

The Solution: A new global trade and exchange currency, which is not the currency of any single country.

- 1) A new global Trade currency, import / export standard currency which is not a currency of any single nation in the World.

Features / Advantages:

- 1) Earthlings will be printed only in 2 or 3 mints, all located in a single place. These mints will be monitored by representatives from all countries (at least one from each country).
- 2) Most forex reserves held by each country must be in Earthlings.

<u>Step 1</u> - The initiative must be introduced at several global forums, such as G20 Summit, WTO, WIPO, UN, World Bank, IMF and all country governments and CB's.

<u>Step 2</u> – Discussions and voting. The introduction would lead to discussions at many levels. Post discussions, a UN voting must be conducted, with one vote per country on the subject. This initiative will be voted in. A governing body must be established (name, governing team and other details).

Step 3 — Once the initiative is voted in, we need to design the currency bills. (a) Billion and Million Earthling bills for CB holdings and exchanges. (b) 1000, 500, 100 Earthling bills for citizen (international travelers) exchanges only. There shall be no other denomination (for e.g., currency bills of 50, 10, 5, 2 or 1 used for local purchase transactions). As no country allows purchase/sale (or local / domestic retail businesses) by using Earthlings. It is only an International trade currency and foreign exchange currency and not for domestic trade or businesses.

Step 4 - 3 Mints that will print Earthlings shall be set-up in a single location. These mints will be governed by all countries (their representatives); and will be under 24*7 surveillance. The location should ideally be in India, China or Europe. City to be selected.

<u>Step 5</u> – Flushing USD's from all non-USA countries. Earthlings shall be printed to replace USD holdings of all countries (their CB's). The exchanged USD's should be retrieved and trashed / shredded (as in truly replaced).

Other ongoing steps - As per CB's purchasing needs against their local currency (or other currencies they hold), they could buy Earthlings from the 'Earthling' governing body. Such an activity of buying Earthlings shall be an ongoing activity.

This may be called as a social scheme, that I do not endorse. I believe that each Country must earn its living and get rich. If the governing body chooses an Earthling distribution step, in a rare global economic distress situation; they shall print and distribute Earthling's equally to every country.

The entire reform could be rolled out in 1 or 2 years. This baselines the World economic situation with a much better balance and gives equal opportunity to all countries in global trade. All countries can aspire to develop and get rich, without any roadblocks.

- Met all the people, everyone I have known or interacted with from my birth until now; exercised authority on them, abused their ignorance in subjects of intellectual property, bribed them, offered a job or business deal, and attempted to make them tell lies, and fabricated negative stories about me, in an attempt to frame me negatively. Intellectual property inheritance law for the record of the Honorable court and respondent.

Intellectual property such as my invention patent us 8,910,998 B1, recognized across 62 world countries by PCT international application PCT/US2014/046619, or for that matter any patent, trademark, or copyright, can only be inherited downwards in the family tree, e.g., spouse and children. Intellectual property cannot be inherited upwards in the family tree, to father, mother, or any other ancestors. Intellectual property cannot be inherited laterally in the family tree, by siblings. Given this fact, I presume no 'medical fraud' was attempted at my father, at any of the hospitals where he was admitted. However, we must legally confirm this by way of investigation.

- e. 15-11-2016: He goes for tests at Padmashree diagnostics Vijayanagar.
- f. 21-11-2016: Padmashree diagnostics report states he has 'Prostrate cancer'. And in that an aggressive one.
- g. Upon consulting Dr. LN Raju, he suggested Laproscopical radical prostectomy. He decided to do the surgery in Sidvin Hospital Rajajinagar.
- h. 04-1-2017 to 11-1-2017: He was admitted to Sidvin Hospital where the Laproscopical radical prostectomy was done by Dr. LN Raju. <u>He was in ICU for two days after surgery with restricted visiting hours.</u>
- i. 19-4-2017 to 24-4-2017: He was admitted to Sidvin Hospital a second time for check up by LN Raju. The discharge catheter continued to discharge blood. In this admission he was not admitted to ICU.
- j. A surgery complication, side effect, Lymph Edema sets in.
- k. 27-4-2017 to 30-4-2017: Due to a sudden drop in blood sugar level, he was admitted to Fortis hospital Nagarabhavi road with consulting doctor being Mrs. Bojamma. His blood sugar level was stabilized and he was discharged. He was in 'Emergency Room' for one day for observation with restricted visiting hours.
- 1. 27-5-2017 to 7-6-2017: He was admitted to Fortis Hospital Nagarabhavi road with consulting doctor being Mrs. Bojamma. <u>He was in ICU for few days with restricted visiting hours.</u>
- m. 15-9-2017 to 28-9-2017: He was again admitted to Fortis Hospital Nagarabhavi road with consulting doctor being Mrs. Bojamma. <u>He was in ICU for few days with restricted visiting hours.</u>
- n. In October 2017 for few weeks he was admitted to Shobha Hospital. There is no ICU at Shobha Hospital. Some part of the day he was accompanied by a domestic help brought on hire.
- o. 21-11-2017 to 11-12-2017: He was admitted to Columbia Asia hospital Malleswaram west with consulting doctor Mr. Ravi Kumar. He was admitted to ICU for few days with restricted visiting hours.
- p. 12-12-2017 to 30-12-2017: <u>He was admitted to Shobha Hospital</u> and had a domestic help covering few hours in the day. There is no ICU at Shobha Hospital.
- q. 30-12-2017 to 1-1-2018: He was admitted to Columbia Asia Hospital with consulting doctor Mr. Karthik Rao. He was in ICU with restricted visiting hours.

- r. The hospital admissions and discharge summary reports that give the hospital address, along with the admission and discharge dates, are attached with this annexure.
- 3. I request the Honorable court to issue orders to respondent to work with 'Ministry of Law and Justice' to conduct investigation at all four hospitals:

 - c. Shobha Hospital, # 29 & 30, Nagarabhavi road, Opposite Prashanth nagar bus stop, Vijayanagar, Bangalore 560040, Ph: 080-23359107, and
 - d. Columbia Asia hospital, 26/1, Brigade Gateway, Beside Metro, Malleswaram west, Bengaluru 560055, Ph. 080-39898969;
 - and legally confirm that 'No legal documents were executed by my deceased father' on all the dates, periods of admission to these hospitals, and while he was in ICU with restricted visiting hours. This is to legally confirm that misusing the medical condition of RA which results in the person not being able to sign, no papers were executed by anyone by using forced fingerprinting, at any of all four hospitals, while he was sleeping in room or at ICU which have very strict visiting hours. The investigation is to legally confirm that no unlimited finger printing was done on blank papers, say 1000'S of them for later use or abuse. No Legal documents must ascertain that no legal documents were executed by using the POA Power of Attorney given to my father by me and my divorced spouse dated 1-1-2009, also attached with this annexure. The investigation must also confirm that no 'Legal statements' were recorded from him by using medical force. And that no 'Death time statements' were recorded by police, lawyers, magistrate, or judge.
- 4. According to the Intellectual property inheritance law' stated above, it cannot be inherited upwards in the family tree. So, there is nothing anyone could legally extract out of my father by forcefully executing finger-printed documents or taking legal statements by medical force, according to law. This investigation by respondent and Ministry of Law and Justice, is to legally confirm the same. I request the Honorable court to issue orders for this investigation, for legal verification and validation to me and the court, that no illegal fraudulent forging work was done at any of these Hospitals. Outside of these Hospital admission dates, my father was at our house, and I spoke to him daily, and if he did want to execute any legal papers he would have done so while at home.

I have attached the following documents along with this annexure for the investigation requirements. All the relevant medical reports of my fathers hospital admissions and the 'Power of attorney' document dated 1-1-2009 given to him for 'a purchase deal' by me and my then spouse Smt. Who could have accessed ICU'S of these hospitals?

- No documents were forged during these hospital admissions, including ICU admissions which have restricted visiting hours, 30 minutes in 24 hours.
- If there was forging of documents, by forced finger printing in drugged state, the investigation must retrieve every last page of the forged documents and take necessary legal action against the perpetrators.
- TO EXECUTE THE 62 SALE AGREEMENTS DESCRIBED IN ANNEXURE D, AND BRING THE FULL WEALTH INTO INDIA AND BUILD OUR NATIONAL TREASURY IN EARTHLINGS CURRENCY. THIS INVESTIGATION WILL ENSURE, NO PORTION OF THIS WEALTH IS STOLEN BY MEDICAL FORCE.

Insertion which was sent for C/S. CXR was done, Cardiology evaluation done with Echocardiography, shifted to ICU for further management.

COURSE AND EVENTS DURING THE HOSPITAL STAY AND TERMINAL EVENT:

On arrival to ICU he was connected to ventilator, continued inotropic support. He was in pulmonary edema a diuretic was given, arterial line was secured. His Urine output was minimal with ABG showing severe acidosis with High lactate. Patient's son was counseled regarding his clinical status, Multi-organ dysfunction had set in with Liver dysfunction, Renal Faillure, Pulmoary edema in the background of preexisting poor cardiac status (Severe LV dysfunction+ Severe Aortic Stenosis) due to Urosepsis and poor prognosis was explained. Nephrologist was consulted and initiated on Emergency Hemo-dialysis after insertion of HD catheter; SLED was performed for 6-8 hrs overnight. Acidois improved briefly after SLED, but by afternoon of 31/12/2017, Patient continued to deteriorate with tumbling BP and increasing inotropic support with both NORAD+ADRENALINE. Urine output remained very poor and acidosis continued to worsen, HD couldn't be performed as his hemodynamics was very uncetable over after being on high dual instructions support. Family was informed recarding the same. Patient had hemodynamics was very unstable even after being on high dual inotropic support. Family was informed regarding the same. Patient had cardiac arrest at 03:50AM of 01/01/2018, CPR was started, Inj Adrenaline boluses given multiple times, inspite of all the efforts put in he couldn't be resuscitated and declared dead at 04:15AM.

If this investigation results in positive devices capture, and proof of privacy invasion, I request the Honorable court to take legal action, applicable criminal action against the occupants of these houses. Obviously, they got these high technology devises from my public enemies, and hence I request the Honorable court issue orders for further investigation on the subject to punish the source, public enemies listed in annexure F.

This investigation must happen to ensure:

- No one is tracking my personal life, daily activity, and attempting to manipulate my life and work.
- No one is following my daily activities and relaying information to foreigners in usa, uk, or any other country, which constitutes anti-India work.
- TO EXECUTE THE 62 SALE AGREEMENTS DESCRIBED IN ANNEXURE D, AND BRING THE FULL WEALTH INTO INDIA AND BUILD OUR NATIONAL TREASURY IN EARTHLINGS CURRENCY. THIS INVESTIGATION WILL ENSURE, NO PORTION OF THIS WEALTH IS STOLEN BY PRIVACY INVASION.

I Request Honorable court orders for appointing 'Twelve member, all Hindu Indian Military unit' until all 62 sale agreements are executed.

A twelve member all Hindu Indian Military unit, to provide security until all 62 sale agreements are executed, in a non intrusive way. Respondent to work with Defense Ministry to identify this team and introduce them to me. The twelve member Military unit will be at my address and spread across the city, e.g., at the Honorable court, and few places I travel within Bangalore to run errands, and few restaurants I visit to consume food.

The military unit, team Leader should have the authority to increase the team size, depending on the 'physical security' requirements over the upcoming months. After the execution of the 'Srinivas - Kathi agreement' described in annexure D, and its 'worldwide press release media conference', there will be a significant spike in the number of people who will attempt to meet me, talk to

me, contact me, ask for my autograph, photograph with me, or my interview. The military unit should be able to barricade the premises at my residential address for security reasons, when the situation demands. The leader of the military unit must have direct contact with Defense Minister and Army General.

There is a possibility of significantly large number of people, crowds gathering at my residential address. My mother lives at the same address. A photocopy of her aadhar card is attached with annexure E. I request the Honorable court to extend physical security to my mother until the 62 sale agreements are executed.
