APPLICATION FOR RESTORATION OF WRIT APPEAL WA 886/2025, ARISING FROM COURT ORDERS FOR WRIT PETITION WP 12356/2023 DATED 14-6-2024, RECOGNIZING 'BREACH OF PATENT COOPERATION TREATY COMMITTED BY UNITED STATES PATENT AND TRADEMARK OFFICE ON 5-8-2015, FOR MY INVENTION PATENT RIGHTS FOR PCT/US2014/046619', AND ATTACHED ANNEXURE A5.

1. I present the following facts connected with this Application for restoration of WA 886/2025, for the evaluation of the Honorable Chief Justice, and issuing the Prayer orders.

- For WA 886/2025, FORM C is issued for me, to represent myself in front of the Honorable court. Form C issued on 12-6-2025.
  - The Party in person committee have done detailed due diligence, reading the entire Writ Appeal, reading the cited articles from constitution of India, CPC sections, Patent Cooperation Treaty articles, and Patent Cooperation Treaty preamble provisions, including the detailed GROUNDS section, addressing each of the prayer point.
  - The Party in person committee after detailed evaluation issued Form C, attached annexure A5, so that I represent myself in front of the Honorable court.
- 2. I have represented myself at High court of Karnataka, argued my cases myself, and procured orders.
- Party in person committee evaluation and decision is procedurally by each case, evaluated independently, and Form C issued. Form C is issued for WA 886/2025 and is attached as annexure A5.
- The cases that I filed at High court of Karnataka, in which I represented myself, appeared in front of the court as party in person, conducted the case myself, argued the case myself, demonstrated professional and business conduct, include WP 21782/2022 status disposed, WP 4851/2023 status rejected giving liberty to pursue justice, WP 12356/2023 status allowed, WP 13823/2023 status dismissed, all of which I represented myself, and procured orders. For WA 886/2025, and WP 24623/2024, I currently represent myself. Form C was also issued for WA 983/2024.
- Justice K.S. Mudagal and Justice M.G.S. Kamal orders issued for WA 886/2025 on 4-8-2025, make a blanket, generic allegation and state the committee must take the orders issued by this bench as a permanent remark, or tag attached to me, blocking JUSTICE for me.
- The capability related remarks for WA 983/2024 issued by Justice K.S. Mudagal and Justice M.G.S. Kamal, must be restricted and limited to WA 983/2024, and must not be generalized. I file this

Jus .

'Restoration of Writ Appeal' application by attaching the Form C issued by the party in person committee on 12-6-2025, providing legal reasons for Restoration of Writ Appeal, only to be heard by Honorable Chief Justice, while he is not presiding alongside the Single Judge Justice C.M. Joshi, and the Judges on the bench that issued orders for WA 983/2024. I made all efforts for the IA 1/2025, of WA 886/2025 to be heard by the Honorable Chief Justice or a bench other than the bench that issued orders for WA 983/2024.

- 3. I have pursued Justice, against 'Breach of Patent Cooperation Treaty, PCT, committed by US PTO on 5-8-2015, for my invention patent rights for PCT/us2014/046619', to sue them since I filed 'Original Suit' OS 2487/2021 in the city civil court of Bangalore.
  - OS 2487/2021 was filed on 9-4-2021.
- OS 2487/2021 was kept in pending status, waiting for me to procure the 'Consent letter' from India Central Government, to address CPC section 86(1) applicable for US PTO and International Bureau, World Intellectual Property Organization.
- Prior to filing this OS, and during the time when this OS was pending in the court, I wrote e-mail communications addressed to Mrs. Uma Sekhar, with all the documented facts and details about the 'Breach of PCT', and also couriered a package with a copy of OS 2487/2021, with the documents attached. I approached them directly requesting them to issue the 'Consent letter'.
- I did not receive the 'Consent letter' when approached with direct communication. While I received a verbal acknowledgement from Mrs. Uma Sekhar, that I would receive the 'Consent letter', I did not receive it while the OS was pending. The OS was dismissed on 13-10-2022, on the grounds of non obtaining of the 'Consent letter'.
- 4. In pursuit of Justice, I came to Honorable High Court of Karnataka, to receive orders directing the respondent to issue the 'Consent letter'.

- I filed WP 12356/2023 on 12-6-2023. I filed WP 13823/2023 on 30-6-2023.
- Honorable court after combining these two Writ Petitions, with possession of full documented evidence, granted orders for WP 12356/2023, dated 14-6-2024, directing the respondent to 'issue the Consent letter', based on full documented evidence and facts. These court orders are attached as Annexure A6. The 'Breach of PCT' with full documented evidence is also recognized by International Bureau, World Intellectual Property Organization, and all the PCT contracting states.
- The 'Breach of PCT' is recognized by the Honorable court with full documented evidence and facts, and is not a subject of alternate interpretations, and alternate understanding. I refer to attached annexure A7 in which I include the illustration indicating 'Breach of PCT articles 18(2) and 19(1) on PCT timeline, already recognized by the court', and a 'Table of patent rights lost, the caused liability in Earthlings, with liability caused dates, by patent territory'. I attach annexure A10, in which I include three illustrations, 'US PTO attempted to block my wealth, and INDIA wealth, while INDIA signed PCT', 'Other sector Industrial applications rejected citing us 8910998 B1 as prior art in ISR and WO', and 'I solve the problem of 'Repeatable vehicle color change', transforming Automotive Industry after 121 years'. The sale price indicated in the table attached in annexure A7, includes the sale of patent rights for the patent territory, combining all the sectors industrial applications.
- For the aforesaid reasons, upon receipt of the 'consent letter', I expect that there would be 'no argument left' in the 'Original Suit', and the Original Suit prayer orders would be received by me.
- 5. Contempt of court orders, committed by respondent, Legal & Treaties Division, Ministry of External Affairs, Union of India, for orders issued by this Honorable court, for WP 12356/2023, dated 14-6-2024, attached annexure A6. I question the Respondent, 'Why have they committed 'contempt of court orders', and why is there a delay in issuing the 'Consent letter'?

- Respondent must immediately issue the 'Consent letter' with reference of the court orders attached annexure A6, and with reference of annexure A7, the illustration indicating 'Breach of PCT committed on PCT timeline, recognized with full documented evidence and facts', and that it is not a subject of alternate interpretations, and alternate understanding.
- The documented facts and evidence are recognized by all PCT contracting states, International Bureau, World Intellectual Property Organization, WIPO, since they have received communications with the illustrations attached in annexure A7, annexure A10, published evidence by WIPO publications, and also including the court orders attached annexure A6.
- Since the respondent advocates are unable to answer, Mrs. Uma Sekhar must be asked to attend the court and answer the court. Honorable court must 'Issue orders for 'Memo under order XXVII, rule 6 of CPC" filed on 11-6-2025, and post it for hearing with Mrs. Uma Sekhar at the earliest possible hearing date. I have attached a copy of the 'Memo under order XXVII, rule 6 of CPC" filed by me on 11-6-2025, as annexure A12.
- Respondent, Mrs. Uma Sekhar must issue the 'Consent letter', hand it over to me in this Honorable court, on the scheduled next hearing date, according to the orders for attached annexure A12.
- The respondent office informed me that Mrs. Uma Sekhar has moved out of the Division, and Dr. Luther M. Rangreji is the current Additional Secretary for the Legal and Treaties Division.
- The person able to answer the questions related to the case would currently be Dr. Luther M. Rangreji who must answer the court, and also must issue the 'Consent letter', hand it over to me in this Honorable court, on the scheduled next hearing date.

US PTO and rouge usa using their entire power, and might, a range of negative tactics used against me.

6. US PTO, and rouge usa, have breached a Treaty signed by 158 World countries. They have built up and used 'Negative tactics' at local, national level within INDIA, and at World countries level. I attach annexure A11 with details of all the negative tactics used by US PTO, and rouge usa, using all their might and power, against me. Proactive neutralization of these negative tactics will allow us to move into the stage of execution of 62 sale agreements. The summary about the cases that would be connected with this Writ Appeal WA 886/2025 is listed here.

Restored Writ Appeal WA 886/2025 in Pending status, according to this Restoration application prayer orders.

- WP 24623/2024 with receipt of prayed orders, must be connected with WA 886/2025.
- A new case with details of my Income tax filings connected with 'recognized patent wealth and income' from PCT/us2014/046619, and neutralizing negative tactics, must be connected with WA 886/2025. I will file this case within next few days.
- 'Original Suit' that I will file upon receipt of 'Consent Letter', for fraud elimination orders, will be connected with WA 886/2025 for execution of 62 sale agreements.
- 'Removal Surgery for removing transmitters and receiver, for remediation of medical malpractice' which I will have a lawyer draft and file the case, given the legal technical elements in the case, will be temporarily connected with the Original Suit, for broadcast of surgery LIVE to World Intellectual Property Organization assembly, and disposal according to law.

The details about these are included in annexure A11.

7. With so many 'Negative Tactics' detailed in annexure A11, used against me, to block the wealth deposited into my bank account in INDIA, to work against 'PCT article 9(1), APPLICANT', me, the Interim prayer orders in Writ Appeals for 'Investigation, and neutralization of negative tactics' were sought sooner.

For all the details provided in annexure A11, and aforesaid reasons,

- I MUST REPRESENT MYSELF IN THE COURT, for all these cases, until 62 sale agreements are signed, executed by me.
- I should be physically present on all hearing dates, in the interest of saving the religion of HINDUISM, saving the lives of 1.2 billion HINDUS living in INDIA.
- I should be physically present on all hearing dates, in the interest of INDIA'S NATIONAL SECURITY.
- I should be physically present on all hearing dates, in the interest of INDIA'S ECONOMIC SECURITY. I am performing my Fundamental Duties for my country, according to article 51A of the Constitution of INDIA. The applicable articles of 51A, include article 51A(d), with reference of 'render national service...', 51A(g), 51A(h), with reference of 'reform;...', and 51A(j), with reference of 'collective activity so that the nation rises to higher levels of endeavour and achievement....'.

While PCT is signed by 158 countries, my authored Macro Economic Reform, Project Earthling© is connected with all 193 World countries.

- 8. I will Introduce my authored Macro Economic Reform, Project Earthling© at World Intellectual Property Organization assembly, addressing all the World country delegations.
- I have introduced 20 slides for INDIA media houses. Full introduction at World Intellectual Property Organization assembly would include an estimated 200-250 slides, in the scheduled '24 hour Introduction Event of the Macro Economic Reform by me'.
- This introduction will be scheduled in the World Intellectual Property Organization assembly calendar, when International Bureau, World Intellectual Property Organization legal representation will come to the court when the 'ORIGINAL SUIT' proceeding is initiated in this court.

- EARTHLINGS COUNCIL organization, EC, will be introduced by me, and the 'EC Spin off documents' will be authored and circulated for the Approval, by Signing, for all the World country LEADERS, resulting in the ESTABLISHMENT and ORGANIZATION of EARTHLINGS COUNCIL. EC will be organized immediately after the 'thumping majority voting result of the Macro Economic reform Project Earthling©, with a mandatory vote, with one vote per country, in a NO or YES option voting'. I will also introduce the other New World Order Councils, and how the Macro Guidance 'cascading effects for Economic progress for 187 World countries' will be implemented.
- International Bureau, World Intellectual Property Organization are informed about this and waiting for the 'Original Suit court proceeding' initiation and summons.
- 9. Interim prayer orders for 'Investigation, and neutralization of negative tactics', are independent from receipt of consent letter, for which court has issued orders, annexure A6, to respondent. I filed a memo indicating this, which was misinterpreted and is the cause of concern.
- With reference of annexures A6, A7, and A10, 'Breach of PCT, the cause of action is recognized with full documented evidence and is not a subject of alternate interpretations and alternate understanding. With this established, the 'issue of consent letter is not a subject of argument', and is independent from the sought 'Interim prayer orders' for 'Investigation for neutralizing negative tactics, and estimation'.
- For this reason, in my communications with Honorable Chief Justice on 6-8-2024, for WA 983/2024, I stated that the court has granted respondent 6 months to issue a 'consent letter', and might grant 5-6 months for the 'Interim prayer investigation work for neutralizing negative tactics, and estimation', and requested that the 'Interim prayer orders' be granted. The issued orders, were to serve a copy of Writ Petition to respondent and stand over.

- With respondent having no objections, I must have received the 'Interim prayer orders'. WA 983/2024 filed on 1-7-2024, office objections dispensed on 31-7-2024, there were court hearings on 6-8-2024, 21-8-2024, and 9-9-2024, when respondent did not file objections, since court orders, annexure A6 directed them to issue 'consent letter'. Hence, after asking for grant of 'Interim prayer orders', I filed a memo, indicating that they are <u>independent streams</u> of work for respondent, for which the work could start parallelly.
- Memo filed under order VI, rule 17 of CPC, by me, on 23-9-2024, was to indicate that the court must grant Interim prayer orders which include investigation for neutralizing negative tactics at the earliest. This is 'misinterpreted' as incorrect step against my party in person representation. This is for the grant of 'Interim prayer orders', since the orders for 'Consent letter' are already given to the respondent. They are not interconnected, or interdependent directly.

- Prayer filed in WA 983/2024 starts with

'I request the Honorable court to issue the following orders, starting with the Interim relief prayer, upon the receipt of 'Consent letter' to address CPC section 86(1), from the respondent, according to orders dated 14-6-2024 for WP 12356/2023.',

was changed to start with

'I request the Honorable court to issue the following orders, starting with the immediate relief interim prayer, according to the orders issued by this Honorable court, on 14-6-2024 for WP 12356/2023, attached annexure B with this Writ Appeal.'

in the memo filed on 23-9-2024. After filing this memo, wanting to expedite the 'Investigation work for neutralizing negative tactics', as separate parallel streams of work, the bench of Justice K.S. Mudagal and Justice M.G.S. Kamal, by daily orders issued on 20-11-2024, revoke my Form C, and have not allowed me to speak in the court through all the subsequent hearing dates. The Writ appeal was dismissed, with court orders dated 22-4-2025, the court orders for WA 983/2024 attached as annexure A8.

- 10. The list of 17 office objections could not be corrected on the court copy, a fresh Writ Appeal file stitched was presented at filing counter with compliance, since the online status of WA 983/2024 showed that it is disposed.
- I complied with the list of 'office objections' issued in WA 983/2024, and with compliance filed the Writ Appeal, after WA 983/2024 was marked disposed, dismissed for non compliance of office objections.
- Daily orders for WA 983/2024, dated 20-11-2024, cited para 9 and para 10 of single Judge orders for WP 13823/2023. According to these paragraphs, I invoked my 'Inherent rights', of India citizen, India National, my Fundamental rights and Fundamental Duties. I filed Writ Appeal, complied with office objections, under additional articles of constitution of INDIA, article 21, my Fundamental right of Privacy, and article 51A, performing my Fudamental Duties. This must not be considered as a new Writ Appeal, since these are arising from the same 'cause of action, Breach of PCT committed by US PTO', and I followed the instructions, daily orders of the court.
- For the remarks against party in person, I demonstrated my capability, knowledge about this lawsuit, by writing everything in great detail, and elaborating the GROUNDS section by each prayer point, since the court would not give time for me to speak.
- With reference of the most advanced technologies, explained in annexures R, S, and T, of WA 886/2025, used against me, and 187 other world countries, our food testing labs and technology labs are outdated and INCAPABLE. Our current day law enforcement is INCAPABLE to mitigate and terminate Internal, Brain, External, and Life cages. Under the provisions of 'Patent Cooperation Treaty, PCT preamble, '...contribution to the progress of science and technology', I must, we must, build this necessary, and immediately required science and technology, to counter the present danger and threat for mankind, and hence prayer CC which was a mere rendition and request to enforce law conventional way, is expanded for immediate registration of Science and Technology Evolution Bank, STE Bank, with initial capitalization of 1.8 lakh crores INR, so that I will incubate and build necessary technology at the earliest.

- I filed the Writ Appeal, since WA 983/2024 was NOT DISPOSED ON THE POINT OF LAW, BREACH OF PCT COMMITTED BY US PTO, and was dismissed for non compliance of office objections. They are the same Writ Appeal. Court registered the Writ Appeal with WA 886/2025. The high court of Karnataka website case status for WA 983/2024 indicated the status as 'Disposed'.
- 11. <u>Section by section response</u>, for oral judgement for WA 983/2024, annexure A8. The online High court of Karnataka website case status for WA 983/2024 indicated, Disposed, with Last action taken, Dismissal for Non Compliance of Office Objections.

Appellant-party in person is present and submits that he is not ready to engage the services of learned counsel.

My response. Form C was issued on 18-7-2024.

2. The party in person committee by report dated 23.02.2025 has certified that the appellant is incapable in conducting the matter in person. Even this Court found that the appellant without required competence to argue the matter simply consuming the time of the Court in arguments consuming the valuable Court's time which could be devoted for deciding other matters.

**My response.** The committee followed the 'daily orders' issued by the court on 20-11-2024. The orders directed the committee to revoke the form C.

3. Despite the Court granting him the opportunity to engage Counsel, the appellant-party in person is recalcitrant and not agreeable to avail the opportunity. The office objections are not complied. Therefore, the appeal is dismissed.

**My response.** This WA dismissed, for non compliance of office objections, and NOT disposed on the point of law, BREACH OF PCT COMMITTED BY US PTO on 5-8-2015.

The registry assigned a new number for the Writ Appeal, however, it is the same Writ Appeal, which must be disposed on point of law, BREACH OF PCT COMMITTED BY US PTO on 5-8-2015.

- The minor edit, keeping all prayer points exactly the same, was to indicate that there is no interdependency between the 'Interim prayer points for Investigation for neutralizing negative tactics, and estimation' and 'Consent letter', since the 'Breach of PCT committed by US PTO on 5-8-2015' is recognized by full documented evidence, and facts, and is not a subject of alternate interpretations, and alternate understanding. This is the reasoning for filing this memo, to seek earliest support by way of investigations to get me out of the attacks with Internal, Brain, External, and Life cages.
- This memo is considered an error and misinterpreted by the Honorable court.
- I never got the time to speak in the court after 20-11-2024, to explain the memo, or talk through the 'Interim prayer points' one by one, explaining that the investigation must start immediately.
- This memo is misinterpreted and the bench of Justice K.S. Mudagal and Justice M.G.S. Kamal, block me out from speaking in the court, and I could never speak of the attacks under the mentioned 4%, requesting urgency for initiating

On 22-4-2025, the WA 983/2024 is dismissed for non compliance of office objections.

14. US PTO, and rouge usa, worked out a plan termed 'last role of the dice, to block me from receiving wealth into my bank account in INDIA, which will protect and save 1.2 billion HINDUS living in India, and save the religion of HINDUISM.'.

### - For WA 983/2024

With Serum package attack used at me since 2008, and within the lower percentage of severity attacks of 4,5, and 4% in year 2024, for Overall, Internal, and Brain cages, already reported to the court, during the time of filing the 'Memo under order VI, rule 17 of CPC',

they used a technique mastered, repeatedly tested for several years before, about planting a set plan, with reference of a decision, course of action of the target subject, and ensuring the target subject will stay with the forced direction set by manipulating the brain regions and holding them in a certain state for few weeks if required. To execute this, the target subject must be in life cage with his/her life and routine pattern documented for several years. It started with my write up on creativity, where I mention 'thought crystallization, thought culmination', after which they put this case study on steroids on me, and several times. It was for using it on me with this memo. With reference of annexure R of WA 886/2025, planting and looping thoughts, 3-4 weeks before, after few days of extreme side, higher side 5% attacks, only one passing thought, 'despite these attacks on higher side, wait for full six months until you receive consent letter', and then for next 3 weeks, the thought of 'severity of pain, your endurance of attacks for 17 years were unbearable, investigation must start immediately' were looped continuously and several times. During these weeks the brain region for 'Information processing is held mostly in numb or neutral state continuously, which results in lower state of functioning of logical analysis and reasoning. The preset looping thought with other brain regions held steady for few weeks, to force activate physical movements, restlessness to force action, will result in target subject 'forced to take action in the set choice out of the options'. This is manipulation of decisions, for decision makers, forcing looping one choice over the other. However, this cannot be used on everyone, since serum package must be dispensed for the full time, period, few weeks to the target subject. World LEADERS, Business LEADERS must get original food and stay away from serum technology cages, refuse rouge usa food, refuse rouge uk food, and stay away from 'serum package' forced decisions. With my decision, waiting V/S file memo, I was forced for 'filing memo', while logically the decision was to get investigation started at the earliest, with this stream of work independent from 'receipt of consent letter', the other option enduring more pain and wait. After 17 years of hit, I considered wait, however, the thought overridden, and the forced action through brain cage was 'file the memo'. The 3,000 case studies which I will author with my team, will address all these scenarios accurately and

thoroughly. This case study built by rouge new jersey, for rouge requests from nyc and dc, for altering and manipulating business decisions, executive decisions, which would alter the recipients of large business deals valued multi million, or multi billion. With me receiving multi Trillion wealth, they used this technique as a last roll of their dice. While WA 983/2024 is dismissed, with this restoration application, the 'cause of action' will be pursued to its legal conclusion.

### - For WA 886/2025

With reference of annexure R of WA 886/2025, case study 33, I introduce 'Serum package counter molecules' for inducing anger, rage, ranting, shouting, and their usage for negative applications. While I have over the past 18 years experienced extreme usage of these 'counter molecules' pushing the higher side control limits, the usage of them within the lowered 4% overall attack on me, has come to usage of these specific counter molecules in finely calculated induced bursts of lower degrees of anger, rage, ranting, and shouting. These are still used during my court hearing timelines. While I have learnt to handle court hearings with these lower dosages of serum packages, there is a possibility of such lower dosage attack 'serum packages' used to manipulate the court hearings, by using them at respondent advocates, or Honorable Judges. Case studies of evaluating court hearings manipulated by 'serum packages', usage of case study 33, is only by observation evaluation of court hearing, since we are yet to organize 'Science and Technology Evolution Zones', 'Science and Technology facilities', establish 'Special Technology Unit, STUN' to trace and report these 'counter molecules', and usage of them in mild dosages to manipulate court hearings. These case studies at the 4-5% intensities, used to manipulate court hearings, translate into immediately granting the 'Interim prayer orders' so that I establish and organize 'Special Technology Unit, STUN', for tracing, extracting, tagging with evidence, and reporting the usage of Internal, and Brain cages, connected with prayer point CC, registering Science and Technology Evolution Bank, STE Bank, and establishing Science Technology Evolution Zones across INDIA.

- With rouge usa, rouge old world order using 'serum technology' poisons to murder LEADERS from across 188 World countries, Ministers in INDIA, the Judicial court proceedings are not immune, with 93 Trillion EARTHLINGS that must be deposited in my bank account in INDIA. Hence, with reference of annexure R of WA 886/2025, there are 3,000 more case studies, which will be authored by me and my team, a team organized by STE Bank contribution, upon receipt of Interim prayer orders', the authored case studies will support MEDICAL COUNCIL, and JUDICIAL COUNCIL.

- The attacks on me indicate how ancient, and out dated, our law enforcement capabilities in INDIA are, compared to the attacks we are dealing with that are futuristic. Most important statement, and action pursued by me, performing my 'FUNDAMENTAL DUTY' for INDIA, according to article 51A provisions of Constitution of INDIA, 'Reform', I want to reform INDIA law enforcement capability to report and dismantle Internal, Brain, External, and Life cages, all of which I am entitled for according to PCT article 9(1), Applicant for PCT/us2014/046619, PCT/IB2016/050993, PCT/IB2016/050994, and PCT/IB2016/050995, read with the Patent Cooperation Treaty Preamble, the Treaty that is breached, which includes '...contribution to progress of science and technology'. I take this step as a early milestone to achieve, while receiving full wealth in EARTHLINGS.

15. Section by section response for oral judgement for WA 886/2025. The court orders for WA 886/2025, dated 4-8-2025 are attached as annexure A9. Print out of high court of Karnataka website 'case status', prayer details section, court directions for WA 886/2025, is attached as annexure A13.

This writ appeal is preferred challenging the order of the learned single Judge dated 14.06.2024 passed in W.P.No.13823/2023 (IPR).

My response. WA 886/2025 is preferred. With the aforesaid reasons, they are the same Writ Appeal, arising from the same

recognized with documented evidence, original cause of action, Breach of PCT committed by US PTO on 5-8-2015, which must be disposed on point of law.

2. Registry has placed the records of

W.A.No.983/2024 (IPR). The said records show that present appellant himself had preferred that appeal challenging the very same order passed in W.P.No.13823/2023 (IPR). That appeal was dismissed on 22.04.2025 on finding, the appellant is incapable in conducting the case and also making certain observations about his conduct. The said order reads as follows;

"Appellant-party in person is present and submits that he is not ready to engage the services of learned counsel.

- 2. The party in person committee by report dated 23.02.2025 has certified that the appellant is incapable in conducting the matter in person. Even this Court found that the appellant without required competence to argue the matter simply consuming the time of the Court in arguments consuming the valuable Court's time which could be devoted for deciding other matters.
- 3. Despite the Court granting him the opportunity to engage Counsel, the appellant -party in person is recalcitrant and not agreeable to avail the opportunity. The office objections are not complied. Therefore, the appeal is dismissed."

**My response.** WA 983/2024 was dismissed for non compliance of office objections. NOT ON POINT OF LAW. Form C issued by party in person committee on 12-6-2025. The Form C committee report is attached as annexure A5.

3. Suppressing proceedings in W.A.No.983/2024 (IPR) present appeal is filed. When once the appeal is dismissed, it is not open to prefer another appeal against the very same order. Therefore, this appeal is not maintainable.

**My response.** I have not suppressed any proceedings. For JUSTICE, on point of law, I filed a Writ Appeal by complying with all the office objections. This is listed with WA 886/2025 (IPR). The online High court of Karnataka website case status for WA 983/2024 indicated, Status Disposed, with Last action taken, Dismissal for Non Compliance of Office Objections, on 22-4-2025.

4. It is also to be noted that in W.A.No.983/2024 itself the Court has opined the appellant is incapable of conducting the case in person. Despite the said order dated 22.4.2025 in W.A.No.983/2024, again 'C' certificate is issued. Registry shall take note of the earlier order in W.A.No.983/2024 in further proceedings, if any, filed by the appellant.

My response. In the GROUNDS section of this Writ Appeal, I have detailed the legal factors by each prayer point. I invoked the inherent rights by invoking articles 21, and 51A of constitution of India. The committee after reading the file in detail, have granted Form C. I am fully capable of representing myself in this case. The Form C committee report is attached as annexure A5.

5. The records reveal that the appellant abusing the process of the Court is frequently filing such cases which conduct is deprecable. For the aforesaid reasons, appeal is dismissed on payment of cost of Rs.10,000/- payable to the Karnataka State Legal Services Authority. If he fails, same shall be recovered as arrears of land revenue.

**My response.** I have never received time for speaking in the court after 20-11-2024, including speaking about and talking through the list of Interim prayer points. I am not abusing the process of court. I will assist the court.

Respondent, by themselves have NO OBJECTIONS for the court issuing orders, since they have recognized the 'Breach of PCT' with full documented evidence, and the Honorable court has issued orders directing them to issue the 'Consent letter'. They have committed 'contempt of court orders'. Since they have no argument in the case, I did not serve a copy of IA 1/2025 to them, and mentioned I would serve a copy if the Honorable court asks me to give them a copy.

It was listed for orders on 29-8-2025.

29-8-2025 I appeared in the court to receive 'Orders for Memo filed under order XXVII rule 6 of CPC to be granted, along with Interim prayer orders granted', and Writ Appeal adjourned for the set hearing date with Mrs. Uma Sekhar. However, the bench would not allow me to speak. They reject the IA 1/2025 with the following.

### ORDER ON I.A.NO.1/2025

### 17. LEGAL SUMMARY.

Across all these past hearing dates, 21-8-2024, 9-9-2024, 24-10-2024, 4-11-2024, 8-7-2025, 10-7-2025, 15-7-2025, 16-7-2025, and 4-8-2025, while Respondent have NO OBJECTIONS against the Writ Appeal, my prayer, I have not received the 'Orders for Memo filed under order XXVII rule 6 of CPC, and Interim prayer orders, with due date set for 5 months to complete the Interim prayer orders 'Investigation and work'. I bring this to the attention of Honorable Chief Justice, and I must be granted the prayed orders. If it is posted for hearing, I must be heard by the Honorable Chief Justice, and I request hearing time of an estimated 1 hour, to present all facts.

### 18. CURRENT STATUS OF RECEIPT OF CONSENT LETTER.

I have not received the 'Consent letter' from the respondent yet.

### 19. CONTEMPT OF COURT.

- I bring the attention of Honorable court to the fact that according to court orders attached annexure A6, and illustration in annexure A7 indicating 'Breach of PCT' proven with full documented evidence and not being a subject of alternate interpretations, and alternate understanding, respondent must issue the 'Consent letter'.
- The court orders annexure A6 are dated 14-6-2024, giving respondent 6 months time to issue the 'Consent letter'.
  - The due date set was 14-12-2024.

- The respondent has committed 'Contempt of court orders' presently at 9 months and 25 days, and counting. Hence Mrs. Uma Sekhar, the person able to answer the questions related to the case, must attend the court hearing at the earliest to answer me and the Honorable court.
- 20. Comparison, preference WA 886/2025. Prayer exactly the same with edits for them to be current, according to filing date 2-6-2025.
- I complied with all the office objections, and expanded prayer CC, for organizing Special Technology Unit, STUN, through Science and Technology Evolution Bank, STE Bank, for making immediate contributions to build INDIA law enforcement capability, inline with PCT preamble.
- Prayer points in WA 983/2024 and WA 886/2025 are exactly the same, unaltered, for all prayer points A through BB, and DD.
- The sentence edits, verbage edits are only documenting the prayer accurately, bringing them to current date, as of the filing date of WA 886/2025, 2-6-2025.
- The only expansion of prayer is with prayer CC, given the INCAPABLE state of current law enforcement in India, to handle, recognize, identify, and report the advanced technology usage of serum technology, nixon technology, intruded electronic devises, and the immediate requirement to build this 'science and technology' capability for INDIA, and for 187 World countries.
- 21. Lack of advanced 'Science and Technology facilities, labs' in INDIA.

Current day India law enforcement is INCAPABLE to detect and report 'serum packages' in two pepsi bottles, tagged with WA 886/2025 number, introduced and described in annexure S, and are still in my possession. The Current day India law enforcement is INCAPABLE to detect and report with evidence imposed 'external cage' in electronic devises, two Lenovo laptops, tagged with writ Appeal WA 886/2025, described in annexure T, are still in my

possession. Current day law India enforcement is INCAPABLE to detect and report 'external cages' imposed on houses, office, Government offices, law enforcement organizations using 'nixon technology'.

Since all the Honorable Justices, agreed to this current status of our law enforcement capability, prayer point CC is expanded to immediately allocate capital for Science and Technology Evolution Bank, STE Bank, so that the 'Science and Technology Evolution Zones' and necessary 'Science and Technology facilities' could be immediately established and we start to build the India law enforcement capability, inline with the preamble of the Treaty that is breached, PCT preamble 'contributing to the progress of science and technology'. While the pepsi bottles are expired, I myself, will own the reponsibility, through the incubated and established STUN 'Special Technology Unit' organization, a unit that specializes in identifying and reporting Internal, Brain, External, and Life cages, by contribution from STE Bank, to detect and report, details of the two pepsi bottles, and two lenovo laptops that are in my possession.

It would be several months from the current date, however we will build the capability, save the lives of 1.2 billion HINDUS living in INDIA, and save the religion of HINDUISM.

- 8. <u>'Removal surgery' which must be conducted, to remove 'Transmitters and receiver' that are placed inside me.</u>

Context. A surgery conducted on me, for induced symptoms, at Millennium outpatient surgery center, 1200 N. Tustin Ave., suite 150, santa ana, ca 92705, in rouge usa, on 20-3-2004, by rouge Dr. Jiri konecny, was for conducting illegal clinical trials, and prolonged data gathering, supporting the rouge second life program of rouge usa, and rouge uk. In this surgery the rouge doctor placed 'Transmitters and receiver' inside of me, and they have captured every sound, of the lowest decibel for this prolonged period of 22 years. I will have a lawyer draft and file this lawsuit, and have it disposed according to law, with civil suit exit, extradition without criminal punishment for the rouge doctor, after finishing the correction procedure. The liability claim for illegal work, gathering data for 22 years, will be considered for World Court at Judicial Council.

#### Legal considerations.

- Connected with 'Breach of PCT' by way of annexure E attached with WA 886/2025. Since the 'Removal surgery' is a non intrusive procedure, I will return to normal life immediately after the surgery.
- By way of a recent communication, Director General and Legal Officer at International Bureau, World Intellectual Property Organization are informed about this 'Removal Surgery', with reference to my website weblink https://srinivasdevathi.in/?page\_id=64, a print out of which is attached with this annexure.
- Must be a civil case, not forcing criminal charges on Dr. Jiri and his team, having a 'Central Government Escorting team', escort them from time of arrival until departure from India, in a case promising safe extradition.

- This safe extradition will enable the doctor and his team to arrive in Bengaluru, India and conduct the 'Removal Surgery'.
- Since the 'Removal Surgery' completion will result in me getting into the execution of 62 sale agreements described in annexure D of WA 886/2025, Mrs. Uma Sekhar, Dr. Luther M. Rangreji, Legal and Treaties Division must watch the 'Removal Surgery' live by video conferencing link from operation theatre. The same video conferencing link will also be used to transmit the surgery LIVE to World Intellectual Property Organization assembly, where all 193 World country delegates will watch the 'Removal Surgery' live.
- At arrival, Dr. Jiri konecny and his team will appear in Honorable court, on day 1, to receive orders. Here I write about a 4 day arrival through departure, safe extradition schedule for dr. jiri and his team, which is at the discretion of the lawyer and Honorable court, e.g., 7 days, according to procedural requirements and scheduled court hearings on the dates.
- Conduct 'Removal Surgery' on day 2. On day 3, Dr. Jiri konecny and his team to attend court hearing with me, along with India Hospital Surgeon, reporting that everything is accurately checked out and I am free of electronics. The India Hospital Surgeon could liaison with Surgeons from other countries, a consortium of doctors from a few countries, other than usa, uk, canada, new zealand, and australia, who could also verify and certify that I am free of electronics, if not by physical presence, by remote video link assistance.
- After legal verification, on day 4, Honorable court issue orders for escorting team to ensure dr. jiri team leaves the country. India court case 'Disposed' according to law. The removed electronics tagged evidence must be handed over to me.
- Because the case involves extradition rules, live broadcast of surgery for 193 country delegations, I will be hiring a lawyer to get this suit filed and get the 'Removal Surgery' completed with extradition with a 4-7 day schedule plan with support of the court.

#### Preparatory steps.

- Identify India Hospital that will participate alongside me, and India in verifying that the procedure is conducted accurately, and ensuring no electronic devises, transmitters, or receivers are left in my body.

- India hospital Surgeon can communicate with World Intellectual Property Organization assembly delegations liaison to identify a consortium of doctors that could verify and certify the procedure, and that I am free of electronics.
- Apollo Bengaluru near High court of Karnataka is well suited. Alternate choice AIIMS if there is one in Bengaluru. Does the Hospital have the 'Surgery facility, and Surgery equipment'? If not, arrange for the same.
- Identify and prepare the 'Escorting team' for securing the doctor and his team from arrival until departure.

#### Respondents in the case are expected to be.

- Dr. Jiri konecny, Millenial outpatient surgery center, 1200 N. Tustin Ave., suite 150, santa ana, ca 92705, in rouge usa.
- Legal and Treaties Division, Ministry of External Affairs, Union of India. They must set up video conferencing link to watch the full surgery live. They also represent World Intellectual Property Organization assembly, ensuring all 193 World country delegations at the assembly watch the 'Removal surgery' live.
- India Medical authority for our side checks. Consideration of Appollo Bengaluru or AIIMS Bengaluru. Appollo Hospital Bengaluru is in close proximity of the high court of Karnataka. This is where the 'Removal surgery' must be conducted.
- Central Government Escorting team or Military team. That upon court orders can escort 'Dr. Jiri konecny and his surgery team' from airport upon landing, until extradited, dropped at airport to board their return flight. An estimated approximate 4 days in Bengaluru. 4 days of work for the Escorting team, according to Honorable court orders.

<u>Prayer.</u> Here is the draft prayer, prayed from the Honorable court. This will be finalized by my hired lawyer before the case is filed.

- For legal reasons, with reference of annexure E of WA 886/2025, I, must execute the 62 sale agreements described in

detail in annexure D of WA 886/2025, at High court of Karnataka. This surgery must conclude while the 'Original Suit' proceeding is in the Honorable court, or certainly before the start of execution of the first of the 62 sale agreements.

- By way of electronic communication, World Intellectual Property Organization is informed about this 'Removal Surgery', and since this is connected with my execution of 62 sale agreements described in detail in annexure D of WA 886/2025, they must watch the full surgery live broadcast at their assembly, having all 193 World country delegations watch the expectedly an estimated 1 hour surgery, budgeting 2 hours for the Surgery video session.
- Request Respondent to set up the video conference and video broadcast link, and share the same with World Intellectual Property Organization assembly.
- Dr. Jiri konecny to perform the 'Removal Surgery' on me, which is broadcasted live to 193 World country delegations, and submit the extracted 'Transmitters and receiver' to me.
- India Hospital where the surgery is conducted, the coordinating Surgeon and his team to be in the 'operation theatre' while the 'Removal Surgery' is conducted, and certify for Honorable court that the procedure is performed successfully. They must have a consortium of doctors from other countries also certify that the procedure is performed successfully.
- India citizen corresponding and coordinating Surgeon and his team, to check me after surgery and certify by a scan that I am free of electronics, and 'Transmitters and Receiver'. They must have a consortium of doctors from other countries also certify that I am free of electronics, and 'Transmitters and Receiver'.
- Dr. Jiri konecny to give a detailed report of 'Removal surgery' and that I am free of electronics, and 'Transmitters and Receiver', to the Honorable court. Appear in court, to get approval orders for returning to his country.
- Escorting team to stay with the visiting doctor and team, from arrival until departure from India.
- I reserve the right to pursue Internal, Brain, External, and Life cage suit, in that Extreme Internal cage used at me for 22 years, with World court at Judicial council.

- PNC Bank statement for period 24-3-2004 through 21-4-2004, indicating the check 307 remittance of 1240 usd, paid date of 24-3-2004, paying the copay for the surgery.

I was absolutely unaware of this at the time. They had 20,000 counter molecules, and waiting to kill me for heart extraction and transplant.

My excellent academic results, followed by work excellence, and recognized top performer and genius, my schedule was packed, and in year 2002 there were random bursts of sweat induced in my palms, with other organs attacked. Disciplined workaholic that I was at the time, could not comprehend these events, given that I was an absolutely fit young man. However, since the network of visitors I had from India, several people I knew, Dr. konecny decides to plant 'high capacity, cutting edge, decades into future for the knowledge levels and understanding of 188 World countries, transmittors and receivers right at the center of my body, for gathering data, since I was considered the best by genetics and a genius', instead of direct murder.

Dr. konecny conducted a surgery on me, what he termed major surgery, for tampering with 'ganglion nerve', which would end sweat in - 80 -

- The devise is a magnifier, amplifier of sounds inside the body, indicative of organs listed and their current function. The amplification is an estimated 1000 times.
- The human body temperature 97.1 degrees keeps these transmittors and receivers active with no charging required until they are removed.
- These transmittors inside my body, through local communication networks, and satellite systems are communicating directly with us pto, white house, pentagon, and Dr. konecny hospital Millennium outpatient surgery center, since they were the one who marked me for heart extraction. The extraction seemed dangerous at the time, so they go for prolonged data capture with experimentation.
- There is certainly one transmittor for select organ, in all a few, given the micro nano size minature advanced transmittors planted.
- These transmittors transmit the lowest of decibel sounds inside the body, including my whisper of lowest decibel, received and captured by Dr. konency and white house.

- The breathing function, the sound of lungs is recorded, amplified every second during this time, these years.

#### The transmitters and receiver removal surgery.







Since, we, in India, do not possess 'technology facilities, advanced BENSCIENCE lab facilities', for conducting 'Serum package identification, extraction, tagging with evidence, and reporting for law enforcement', and similarly for 'usage of external cage 'nixon technology' at homes, offices,

Government and Industrial buildings, its tracing, extraction, tagging with evidence, and reporting for law enforcement', imposed external cages on electronic devises, I, the Applicant according to article 9(1) of Patent Cooperation Treaty, for PCT/us2014/046619, PCT/IB2016/050993, PCT/IB2016/050994, and PCT/IB2016/050995, read with the Patent Cooperation Treaty Preamble,

Convinced that cooperation among nations will greatly facilitate the attainment of these aims,

Have concluded the present Treaty.',

the Treaty breached by united states patent and trademark office, US PTO, on 5-8-2015, desire to 'BUILD extremely strong and advanced science and technology capability for law enforcement in India, immediately, my overall work in INDIA, spanning a gamut of work, a BENGALURU which is described in WA 886/2025'.

In line with the PCT Preamble provisions, I must receive the 'Interim prayer orders' immediately, so that I register 'Science and Technology Evolution Bank, STE Bank' immediately, and establish 'Science and Technology Evolution Zones' across India, and organize India Special Technology Unit, STUN which will advance law enforcement capability in recognizing and terminating advanced threats for mankind that include imposing Internal cage, Brain cage, External cage, and Life cage.

Since INDIA JUDICIARY, with agreement from the Honorable Justices themselves, that we do not possess 'technology facilities, advanced science lab facilities', I have retained in my possession, two pepsi bottles introduced and explained in annexure S of WA 886/2025, and two Lenovo laptops with their power cords introduced and explained in annexure T of WA 886/2025.
