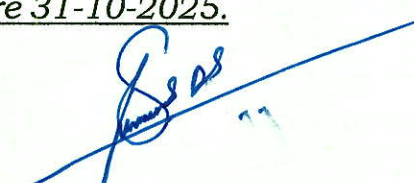
MEMO FOR POSTING

I include a copy of Party-in-person Committee, 'Office report dated 12-06-2025', two pages, with this memo for posting.

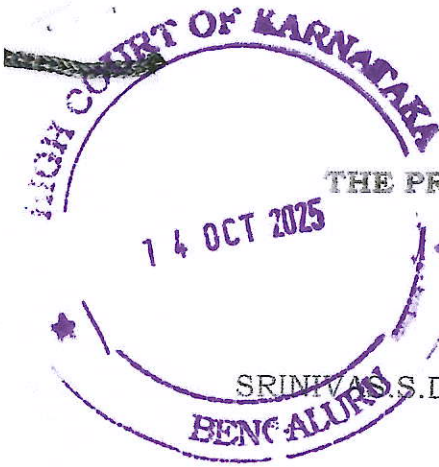

Matter called before the Party-in-person Committee.

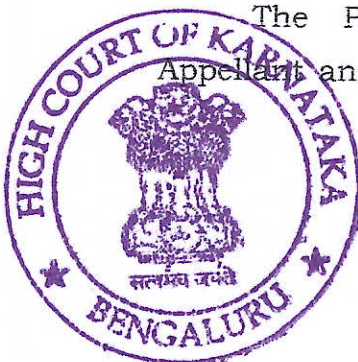
Appellant, who is a Party-in-person appeared before the Committee physically.

has been guided about the mannerism and the language to be used and the decorum of the Court to be maintained.

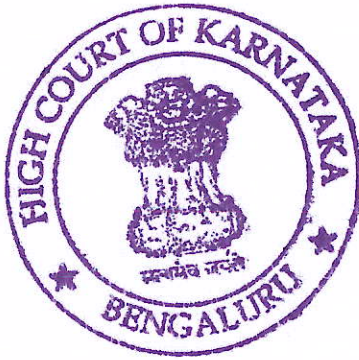
