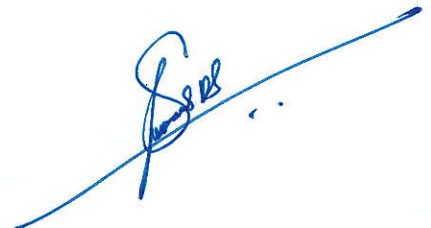

**MEMO FOR PRODUCTION OF ADDITIONAL DOCUMENTS, FOR
ALLOWING IA 2/2025.**

1. I submit an additional supporting document, annexure A27, for the consideration of the Honorable court, so that the IA 2/2025 is allowed, and the Orders are granted at the earliest possible date.



2. A copy service delivery to otherside counsel acknowledgement to be filed.

I attach annexure A27 with this memo, which includes the original India post, speed post receipt, with tracking number EK311446392IN, dated 3-7-2026, the India post website online status print out of the package delivered to the respondent advocate on file, and my current account number 34860071638 SBI bank statement for the date 3-7-2026, showing remittance of INR 60, for Department of posts.

3. Provision of law.

I am the Inventor, and Applicant according to Patent Cooperation Treaty article 9(1), for PCT/US2014/046619, PCT/IB2016/050993, PCT/IB2016/050994, and PCT/IB2016/050995. United states patent and trademark office committed breach of Patent Cooperation Treaty with my patent rights recognized by PCT/US2014/046619, on 5-8-2015, causing loss of my patent rights including all the 'Industrial applications', in 60 countries. The provision of law connected with investigation prayer points in the Writ Appeal interim prayer sought includes articles 21, and 51A of constitution of India.

4. Detailed affidavit to be filed before annexures.

I will get the IA 2/2025 restitched, rectifying this office objection.

5. Prayer to be clarified.

I present the clarified prayer points 22A, 22B, 22E, and 22F. Rest of the prayer points are same as the ones filed on 17-10-2025. According to website weblink <https://www.mea.gov.in/divisions>, Mr. Yedla Umashankar is the current Joint Secretary for Legal and Treaties Division.

For the aforesaid reasons, arising from the Honorable court orders for Writ Petition WP 12356/2023 dated 14-6-2024, recognizing 'Breach of Patent Cooperation Treaty committed by united states patent and trademark office, on 5-8-2015, for PCT/US2014/046619', and attached annexure A5, I pray the Honorable court to grant the following orders.

A. Set aside the impugned orders for WA 886/2025, issued on date 4-8-2025.

B. Set aside the impugned daily orders issued on date 29-8-2025, for IA 1/2025, in WA 886/2025.

C. Restore the Writ Appeal WA 886/2025, and bring it to 'PENDING' Status. Indicating there are no duplicate Writ Appeals filed from me, mark Writ Appeal WA 983/2024, permanently dismissed, restricting the court order remarks about me, party in person only to WA 983/2024.

D. Set aside the Impugned orders issued for Writ Petition WP 13823/2023, dated 14-6-2024.

E. Grant orders for 'Memo under order XXVII, rule 6 of CPC', filed on date 11-6-2025, with the earliest possible hearing date set with Mr. Yedla Umashankar, ideally within the next 4 weeks.

F. Respondent, Mr. Yedla Umashankar, to issue the 'Consent letter', hand it over to me in the Honorable court, on the set hearing date according to the orders for 'Memo under order XXVII, rule 6 of CPC', filed on date 11-6-2025.

G. Grant Interim prayer orders, giving respondent 5 months time to complete the 'Legal investigation and work', in the interest of Justice and Equality.

6. Non filing of acknowledgement for having paid cost of 10,000/- to the Karnataka state legal service authority by appellant / party in person v/o dtd 4/08/2025.

In IA 2/2025, one of the prayer points sought, 22A, is for setting aside the impugned orders issued for this Writ Appeal, dated 4-8-

2025, which includes the text for the V/O orders, and hence would also set aside the V/O orders. However, I can pay court fees, in the court fee counter for the 'Hearing time' allowed for me and if required that I request be allowed, according to whatever amount of court fees the Honorable court directs that I pay. I can pay 20,000 INR, and upto 50,000 INR immediately, according to courts orders.
